3 - 1      Village Halls

There was some concern expressed with the lack of progress in refurbishing the former play area at Pilning playing fields. Agreed the contractor should be contacted.

The chain link fence at the tennis court has been repaired. New post sockets have been fitted, the posts and net are stored by the Clerk. Agreed that with the tennis season coming to a close the new posts and net should not be mounted until spring.

3 - 2      Overgrowth

Growth at various sites has been cleared, though that at Northover Court is still a problem. The owners of number 5 are on long-term absence. The main problem here is nettle growth on the footway. AW agreed to cut back the nettles to prevent problems for children returning to school this week.

3 - 3      Cross Hands

Growth around the Bolisha beacon has been cleared. The beacon is now clearly visible. PT confirmed flashing signs to be sited in Cross Hands Road have been ordered, but, as yet, have still not been delivered.

3 - 4      Schools

Carla Jones, representing architects/engineers, acting on behalf of S Glos Council, attended at Pilning playing field and Sage Cottage during last week. The brief was to consider the suitability of the area as the site for St Peter's School. ## 6. PUBLIC PARTICIPATION

Mrs Gill Cox presented a case for the funding of new play equipment at Severn Beach. Agreed that forward payment of the precept allowance could cover the cost (50% funding would require around £9,000). An alternative would be an interest-free loan. In setting the annual precept in December it is an option to increase funding for play equipment. Current funds held by council are also in excess of the norm. Accordingly, funding could be available for other projects, yet to be identified, that may arise during the period when 'normal funding' has already been utilised.

## 7. AGENDA

### 7 – 1 Severnside Development

Local PCSO, Kirsty Flicker has already mounted a clamp-down on illegal bikers, albeit on a 'quiet' day. Police now have an option to confiscate and destroy bikes after a previous warning has been issued.

S Glos Planning Committee has considered the proposed access at Marsh Common Road, delaying a decision as they considered advance research by the applicant had been sketchy. In respect of the extant ICI permission from 1957, PT is to put forward a case for this somewhat archaic permit to be rescinded.

### 7 – 2 Village Halls/Playing Fields

NC reported that a new group for children has been set up, meeting on Thursdays, in Pilning VH.

Vandalism has resulted in the need to fit 2 new doors at Pilning VH. The cost of almost £1,400 per door will be met from the precept.

### 7 – 3 Parish Plan

JD reported that some questionnaires were still being returned. Part of the delay has resulted from some volunteers not following through properly on the collection system that had been set up. Costs for analysis of the comments are quite high. This process is likely to take more than a month. Many questionnaires have been completed by more than 1 person. There is also a pleasing willingness for people to become involved. Strong and favourable opinions have also been noted.

### 7 – 4 Youth Activities

NB reported on the progress so far. Quotes have been obtained and many ideas considered. Although the possibility of a deal with S Glos Council regarding the site of a new school may alter matters in the future, agreed NB should give no consideration to this, it currently being only a possibility. NB reported on the Childrens' Society day out, when local youngsters were taken to Avonmouth for a go-carting session. NB is to meet with the S Glos Youth Officer, and will be attending a fund raising opportunity on Wednesday.

### 7 – 5 Grass Cutting

IH complained of the current standard of grass cutting. Redwick crossroads and many road verges are among the problem areas. S Glos to be contacted.



#### 7 – 6 Finance Regulations

Prepared by the Clerk and circulated to all members. The Regulations were adopted without comment.

#### 7 - 7 Village Matters

**Rifle Range** – IH advised that problems with a locked gate had again arisen. Following the temporary removal of the padlock it is now back in place.

**Churngold** – Contact to be made with planning enforcement. The occupants have not complied with the conditions and their obligations.

**Weight Limits** – AW asked whether more 7.5 tonne limit signs could be placed. Problems are particularly bad in Bank Road.

**Northwick Road Bridge** – AW drew attention to the condition of the boarding, which is de-laminating. Much correspondence has been exchanged on this matter in the past, with no result. Agreed to again raise the matter. Suggested the problem should also be referred to the Area Forum meeting on Wednesday. The displacement of the road sign at this site was also raised.

**Garden Maintenance** – The council gardens to the rear of houses opposite SB shops are in need of attention. PT also drew attention to the small site adjacent to the bus stand at 100 Beach Road. Both are to be referred to the Odd Job Man.

**Public Conveniences** – There was some initial comment, the general feeling being that their condition is fairly reasonable. The lack of soap is a ‘day-to-day’ issue, the responsibility of the maintenance team. PT stated it would be possible for the parish council to take over maintenance of the toilets. The Clerk, in response, commented on the difficulty in employing someone to maintain the facilities, whilst a dedicated team already exists at S Glos. Councillors appeared to be unwilling to comment further. Michelle Dixon from S Glos has promised to check out the facilities.

**Annual Awards** – Pilning, the garden award went to Mrs Olive Singer, Cross Hands Road. SB, the garden award went to Mrs Sybil Heal of Beach Avenue. Mr Mervyn Jacobs received the allotment award.

#### 7 – 8 Reports

**SB VILLAGE HALL COMMITTEE** – DN reported on his attendance at the committee meeting, stating that electrical checks had revealed a catalogue of possible disasters. The need for 32 improvements has been identified. The cost of repairs is likely to be in the region of £6,000. Although absent from the meeting, DH had earlier indicated the problem to the Clerk, stating it was the committee’s intention to proceed in stages. Early work would require the grant of the entire precept for this year (£2,500).

**ABLETON LANE** – PT, in discussion with Oliver Mann the Streetcare Inspector, complained of the poor quality of the resurfacing process. Supposedly for economic reasons the road was not planed and resurfaced, a newer procedure being employed. Obviously not successful – one wonders where the economy went. PT suggested the road should be scheduled for re-surfacing in 2 years time.

**PARKING ORDER** – PT commented on the order, mentioned in correspondence. This would be an opportunity to consider the removal/extension of double yellow lines – for example, parking restrictions outside the Severn Salmon, the pub having been demolished in 2002.



RIFLE RANGE – (Mentioned earlier) PT met with the RoW Officer, who confirmed that a new gate had already been ordered, though obviously not yet fitted. This gate can be locked to vehicles but still allow pedestrian access.

SCHOOLS – PT confirmed that St Peter's School is now officially opened. Funding allocated to SB School will still be provided, even if it is necessary to obtain this money from reserves.

NEW PASSAGE – Residents concerned by speeding vehicles are currently being served by a temporary flashing speed sign which also records numbers exceeding the limit. This could result in further action.

FOOTPATH – PT confirmed that Scouts had done their good deed recently, clearing one of the footpaths at Northwick.

SEVERNSIDE SIREN – Attending the recent meeting PT raised the question posed by many local residents; their inability to hear the siren. Although an extra siren is needed in the Hallen area, the group was adamant that if you cannot hear the siren there is nothing to worry about. Should the siren be inaudible it indicates the wind is blowing in another direction, carrying any fall-out with it.

FRIENDS of the EARTH – Actively investigating power options from the Severn. Steve Webb MP is supporting a proper study of all available opportunities, including the use of a barrage.

DEVELOPMENT in REDWICK ROAD – PT confirmed the Internal Drainage Board are satisfied with the drainage work carried out adjacent to the 2 new houses almost opposite the Kings Arms.
