2017-11-8 Reports	<p>SevernNet Transport Forum: PT Two presentations by Highways England 1 - Clive Perkin, Divisional Director(Strategy & Planning) talking about the Severn bridges - The transfer from the Concession back to Govt will be on 8th Jan 2018, and on that day VAT will be removed from the toll so there will be a reduction in the toll. The tolls will be completely removed at the end of 2018. The toll receipts during that period will be £100million. At the end of 2018 they will have to remove the toll booths and toll plaza, and revise the layout to be just a continuing motorway. The Toll area at Aust brings a particular problem as the toll booths support a bridge, which is the Severn Way footpath, so they will have to discuss with SG whether to divert the path or build a new bridge. Traffic modelling suggests that there will be an increase of traffic by 43%.! 2 - Mohsin Shareef, Project Manager for M49 Junction. Contractor to be announced very shortly. They will be doing a full review of their detailed proposals in November, with a view to making an immediate start before the end of this year. Pre-commencement work involves moving one pipeline and protecting another; it also involves moving a rhine, and they will be providing a new culvert under the junction. (I saw James from LSIDB this morning, he confirms the new culvert will enable them to divert more drainage to New Pill and so relieve some of the flows to Chessel Pill). He told us about how traffic through Easter Compton and Pilning should reduce after the junction. Rep from Almondsbury PC asked for a signed copy of the slide showing the bar charts (joking), but we agreed that 'reduction' probably meant a reduction in the rate of growth. Asked about how this was affected by the increase of traffic on the bridges, he said that the M49 modelling was having to be re-done to reflect that prediction. Planned construction completion by end of 2019, but opening would depend entirely on the developers completing the access roads and these being adopted by SouthGlos/Bristol CC. Jo Perry from SouthGlos - proposals to resurface Govier Way (the road is coming apart on the roundabout where Tesco trucks turn). Road closures will be a nightmare for the businesses. Follow-up to A403 works. I asked for the footpath from Ableton Lane to Central Ave to be upgraded to cycleway, as we requested originally. Talking about traffic volumes, Rep from Coop said that they deal with 600-800 truck movements in 24hrs..(one every 2mins) SevernNet bus running now only to the Avonmouth/Cabot Park part, a circular route from Avonmouth Station. They are working with Lidl and</p>

	<p>others to develop a plan for a similar service for Western Approach/ Central Park from Severn Beach Station.</p> <p>This led to a discussion of the potential for a route to be built from Pilning Station across to Tesco and into Govier Way. This is now a positive request on a wish list for the future, as development allows.</p> <p>Access Funding: there is 50% match funding available from SouthGlos (and Bristol CC) for bus shelters, to encourage bus uptake.(we need to enquire - Richard Drew was due to speak, but sent apologies) - something for our Precept meeting please, Victoria?</p> <p>SevernNet are coordinating + setting up a meeting of all the companies on Severnside (Western Approach and Central Park). This proved very fruitful when they did the same in Avonmouth, it enables the companies to work together to put pressure on the Council to get things done and also showed the companies where they could help to fund things to make them happen.</p> <p>There was general disappointment with the lack of response from the Metro-Mayor.</p> <p><u>Playing Field Report - SCB</u></p> <p>The field has recently been cut and has some small lumps of grass lying on top, would not think it would be a problem.</p> <p>Small amount of rubbish in teenage shelter.</p> <p>New piece of equipment impressive but spoilt by large amount of litter under and around it. Perhaps people did use the bin. No litter elsewhere and not much in bin outside gate.</p> <p>Older play equipment appears to be fine though the small hole in tilt ring is getting bigger.</p>

To agree the refreshed Charter between S.Glos Council and Town & Parish Councils</p> <p>PT explained the background to the refreshed Charter between S.Glos Council and Town & Parish Councils and the importance of understanding between S.Glos Council and Town & Parish Councils. After discussion, it was agreed to insert a new bin near the new piece of play equipment.</p> <p>c) Update regarding the extension at Pilning Village Hall – VB explained that the management committee had been advised to push forward with the necessary arrangements to make sure the planning application is not lost. ND advised that it would be necessary to advise the insurance company ahead of any build works.</p> <p>4. Update on allotment sites</p> <p>KW offered to give VB an up-to-date list of the unworked plots at Severn Beach.</p> <p>SCB advised that all plots are in contract but some are unworked/underworked. VB to ask Tim Dark to remove the former compost area at Pilning.</p> <p>5. Update on Cemeteries</p> <p>SCB reported the gravel yet to be completed. FCAB to ask Tim Dark. NC questioned whether the graves at Northwick are subject to a 75 year lease. FCAB advised that she thought the graves were not subject to a 75 year lease but NC & FCAB to check this.</p> <p>6.
