SOUTH GLOUCESTERSHIRE COUNCIL (FOOTPATH BETWEEN SEVERN BEACH RECREATION GROUND AND PUBLIC FOOTPATH ORN 19 AT SEVERN BEACH) DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2024

This Order is made by South Gloucestershire District Council under section 53(2) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the South Gloucestershire District Council Definitive Map and Statement for the former Thornbury Rural District require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The South Gloucestershire District Council hereby order that:

1. For the purposes of this Order the relevant date is 1 January 2024.
2. The South Gloucestershire District Council Definitive Map and Statement for the former Thornbury Rural District shall be modified as described in Part I and Part II of the Schedule hereto and shown on the map attached to the order.
3. This Order shall take effect on the date it is confirmed and may be cited as the South Gloucestershire Council (Footpath between Severn Beach Recreation Ground and public footpath ORN 19 at Severn Beach) Definitive Map and Statement Modification Order 2024.

## SCHEDULE

### Part I

#### Modification of Definitive Map

##### Description of path or way to be added

A footpath commencing at the boundary in the south east corner of the Severn Beach recreation ground, **Point A** on the order plan (grid reference ST 5438 8471), and running in a northeasterly direction across a field for a distance of 92 metres to meet public footpath ORN 19 at **Point B** (grid reference ST 5445 8477), southwest of the field exit onto public bridleway ORN 54. Shown as a bold broken line marked **A – B** on the map contained in this order.

The width of the path is 2 metres throughout its length.

The total length is 92 metres.

The number of the footpath to be added is **ORN 81**.



The South Gloucestershire District Council hereby confirms the foregoing order as an unopposed order this 12<sup>th</sup> day of June 2024 in accordance with the resolution of the Public Rights of Way and Commons Registration Sub Committee at the meeting held on 30<sup>th</sup> November 2023, Minute No. 26.

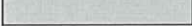
