3. Review of actions from the previous meeting and matters arising

8. Parish Characterisation Study

Guidance document has been supplied by ST.

Objective is identify areas of different appearance and feel in order to retain or enhance areas of similar land use. Initially to use a map identify areas of difference in the parish supported perhaps by use of Google Maps/ Street View. Then walking the areas in groups to assess and photograph to produce a report Sub group volunteers so far: MH (to lead) ND, JE, ISR and RE.

First action of the subgroup is to read the guide supplied by ST now on shared drive (31/03/2022)

9. Communication with other Agencies

RE & JM attended the Strategic Infrastructure-led Masterplan for Severnside workshop — This is being created by Atkins, at the initial consultation stage currently. Questions raised over understanding of relationship with Local Plan (RE is awaiting a response from Danny Dixon), and what "Active Greenbelt" means. RE reported the area covered is south as far as Hallen and completion date is by the autumn. The Masterplan is expected to be relevant for around fifty years and is being worked on in association with the South Glos Regeneration Team. AW & RE — meeting with University of Bristol regarding the survey data work.
