Presentation from South Gloucestershire Council Cabinet Member Chris Willmore

The meeting welcomed Cllr Chris Willmore (Cabinet Member SouthGlos Council) who updated the meeting on her work which includes

- Heritage (and museums group);
- Strategic planning;
- Regeneration;
- Infrastructure (buses/ trains etc.).

CW took questions from the attendees.

M49 J1 The meeting was updated that the final landowners involved with the M49 link road had now signed and that the work would commence shortly.

<u>Number 12 Bus</u> It was reported that there is real danger that bus services 12 would be cut at the next round in April due to funding issues. CW urged attendees to use the services as much as possible and give feedback on what services are necessary. It was confirmed that the 918 bus would be supported for the academic year.

<u>Truck stops</u> A resident raised the issue of Truck stops. CW offered to receive feedback on suggestions for suitable sites.

<u>M48 Crossing weight limit</u> - The issue was raised regarding HGV's continuing to use the M48 Severn Crossing despite the temporary (soon to be permanent) weight restrictions. CW offered to feedback this to the relevant department.

<u>Broadband speeds in the parish</u> - OT requested advice on how to approach the issue of broadband speeds, particularly in Northwick. CW offered to find out and liaise with OT directly on a plan of action.

3 Minutes of the previous Parish Council Meeting

The minutes of the previous Parish Council Meeting held on the 7th April 2025 were unanimously approved as a true record with one minor amendment.

4 Matters arising / actions

- <u>56/876 Severn Beach train noise</u> MP asked GWR about the continued usage of class 166 units on the Severn Beach line and whether class 175's could be deployed. GWR are looking at battery electric traction, but this is not likely to be implemented until the 2030's. Suggested that MP meets with Claire Young MP to encourage government and GWR further.
- <u>144/854 Broad Gauge rail display</u> Timbers are on the concrete plinth, not yet set up; Clerk has had wording approved by the Local History Group for the interpretation board. Design to be finalised by LHG. Work to resume once better weather arrives. Clerk has chased PT and Local History Group. LHG is busy on producing their next publication.
- <u>150/56 Flooding preparedness exhibition</u> Almondsbury, Aust & Oldbury on Severn are keen to make a joint approach to South Gloucestershire Council. Clerk to contact South Gloucestershire Council to start the process. Sean Rhodes agreed to ask the relevant officer. Update requested from S Rhodes.
- <u>155/209 Complaint regarding lights by Ableton Court</u> Clerk tried to contact Connelly & Callahan, no response. Clerk requested South Gloucestershire Council to light the public footpath, no budget to do so. Clerk's second attempt was more positive with Connelly & Callahan, a solution is now being actively sought. Clerk sought an update 30/04/2025.
- <u>158/355 Cemetery visit</u> Clerk to visit Almondsbury and Thornbury cemeteries to assess best practice.
- <u>158/365 Northwick Tower</u> Roofing contractor due to commence work shortly at a cost of £200/ day and an estimate of 10 days to complete the work. The scaffolding company required a further fee of £1000 for the hire and supply of scaffolding due to the extended length of the contract.
- <u>160/456 Beach Road leaflet</u> Clerk to compose the leaflet and method of data collection needed for the consultation.
- <u>161/464 Bank account closure</u> Request received and is being processed by Lloyds.
- 161/466 Grant for South Gloucestershire Council ABCD scheme To be started
- <u>161/492 Charity obligations report</u> Details sent to ALCA for consideration.
- <u>161/493 Recent conflicts memorial benches</u> Wording and plaques agreed with the veterans. Locations have been confirmed, Clerk organising the concrete plinths for the benches.

Further groundworks were required at the Severn Beach allotment site to complete the car park and entrance and break up the concrete slab of the former clubhouse. ND advised that two quotes had been received but one advised that they couldn't get good prices for stone (over £20/tonne) and they recommended we source it elsewhere. ADD Plant labour was cheaper than SWG at £1400. SWG quoted £2500 for stone (£20/tonne) plus £1800 for labour. ND advised that it was his view that both had overestimated the labour but if a lower quote for stone were achievable then ND could negotiate the labour with ADD Plant.

The meeting agreed that ADD Plant would be instructed to break up the concrete slab in the agreed sum of £670 + VAT.

The meeting agreed that ND must receive a second quote for the stone and then he may accept the lowest of the two quotes.

Appendix C NPSG Report

Neighbourhood plan update: Since the last PC meeting the NPSG met on 22nd April.

Matters discussed at the Steering Group meeting and arising since are as follows:-

Flooding: We received the first draft of the Level 2 SFRA from JBA consulting on Friday 2nd May. This came later than we were expecting at the time of the last PC meeting. It is a comprehensive 48-page document supported by Appendix A, the overview mapping for the Parish of different flood data and Appendix B the maps for the 9 individual potential sites and the summary tables for the 6 combined areas.

The Steering Group has carried out an initial review of the documents and today has returned a number of comments and proposed amendments to JBA.

The bottom line is we believe the document will make an appropriate flood risk case acceptable to SGC and the EA that would allow new development on potential sites, in line with the parameters given in the Design Codes and Guidelines Report, available on the website.

SEA, HRA and Evaluation of Sites: These pieces of work (Strategic Environmental Assessment and Habitats Regulations Assessment) were put on hold whilst we awaited the flooding solution. We have a re-start meeting with consultants AECOM this Thursday.

SGC Local Plan: The Steering Group submitted its comments on the New Local Plan on 11th April.

Planning: The Steering Group has submitted objections on the planning portal for the 3 applications reported at the last PC meeting. Following discussions at our last Steering Group meeting, an objection has been submitted for P25/00144/F, the retrospective application for a traveller site at Northwick. Additionally, a comment of support has been submitted for P25/00943/F the community shed in Severn Beach.

Appendix D Unitary Councillor Report

Key updates for Parish Council colleagues in May 2025

- A much quieter month so far, primarily due to me taking 10-14 days away, and the impact of
 the Easter break as well as the WECA election period where much of the usual political
 discussions were on hold. Parish Council colleagues will note that Helen Godwin (Labour) won
 the election as is now the new West of England Combined Authority Mayor. This role is
 growing in importance, as more UK Government decision making is being localised to elected
 Mayors in the months and years ahead.
- It's great to see the Model Railway scheme now progressing through the Parish Council and towards South Gloucestershire. Formally submitting a planning application will provide clarity for all parties, enable local people to share their views, and give certainty to the team and volunteers looking to bring back the history of Pilning & Severn Beach.
- There are areas of work in progress, including the much-needed meeting with Road Safety to address challenges in Pilning and Hallen, as well as speed limit requests outstanding in New Passage.
- With the WECA election now concluded, we are simply waiting on the formal announcement and communication regarding the 918-bus service which Cllr Wilmore and colleagues have worked tirelessly to retain in the ward with South Glos and WECA teams working collaboratively.
- To date I'm yet to resolve the resident concerns in both Pilning and Severn Beach with residential homes being used by private operators to house people in a residential / caring capacity. Having liaised with SGC Officers, no-one is aware of the organisations residing in the ward, but I am continuing to look into this.

Cllr Johnson was thanked for his report.
