7. AGENDA**7 - 1 Severnside Development**

Reported travellers now camped on Western Approach. PC Lodge commented on several problems within the district. It was also noted that travellers were seen examining the entrance to the foreshore on A403 with a view to gaining entry. Concrete blocks were placed there following the illegal camp last year.

7 - 2 Village Halls/Playing Fields

7 - 3 Parish Projects & Related Matters

CW informed council that minutes of the recent Parish Plan Steering Group meeting are now available. The schedule, including the group on the council's insurance policy requires that a parish councillor must be present at each meeting. CW confirmed that she and SC were willing to conform to this requirement. IH agreed to act as substitute should neither be available.

7 - 4 Footpaths

MP is one of several councillors contacted over the closure of the footpath adjacent to 114/116 Beach Road. PT has obtained the relevant forms to register use of this path. Mrs Barr informed members that the path had been open for just less than 20 years, although DH stated he had used the path when he was a boy. Although there is some thought that the alignment of the path may differ from that of the original, DH believes the path follows its original route.

7 - 4 Footpaths (cont)

Ben Holt of Clarke Willmott has promised to expedite the response from Sims Cooke & Teague in respect of the right of way at Pilning playing fields and hopes to meet with members later this month. Agreed that council should seek to register the path, by following the procedure employed in respect of the closed path at the sea wall.

7 - 5 Village Matters

Mini Motorbikes – MP reported on problems with bikers buzzing around the local open spaces. DH confirmed he had narrowly escaped injury following a recent incident. Many of the riders are local, and are known to members. PC Lodge confirmed that reported incidents would be dealt with, dated digital photos would be particularly useful in dealing with the problem.

SB Regeneration – The Group AGM is to be held on 19th October in SB School.

School Awards – CW confirmed that James Hathway of R&N School was delighted to receive his award. DH suggested that Ryan Hathway at SB School was equally delighted,

Police Station – NC reported on work being carried out on the building. There are many rumours concerning what is happening. PC Lodge confirmed that he also was unable to offer any help, though he, too, could offer opinions based on rumour.

Allotments – NC reported that one allotment was not being worked. Clerk to speak with the occupant.

Overgrowth – DH observed that overgrowth at the end of Abbott Road was in need of attention.

4 Towns Transport – An unfounded complaint has been made against IH, following a problem with a parked car. IH is upset by the allegation, though all passengers on the bus confirmed it is untrue. Council to write supporting IH.

Church Road – Recent confusion involving emergency services has led to a request for a road sign for that stretch of road to the east of the junction with Little Green Lane. This should help prevent future problems.

Industries on the A403 – IH drew attention to the various sites set up along the A403, close to the Bristol border. He questioned the permits for this development. PT confirmed that planning law does not necessarily require a knowledge of all that is involved. Any enquiry would need to be via enforcement to check whether all permits are being complied with.

Chessell Avenue – NC informed members of the nuisance created by youths gathering near the garages. Drinking is one problem, but the main concern must be in respect of improper use of air rifles in a public place. Police have been informed.

7 - 9 Reports

POLICING – PC Lodge gave details of the new policing plan. Its effectiveness is being tested in Bristol, and it will become live in S Glos in April, and be tested in some areas. It is hoped that that PCSO numbers will be increased. In particular this area should benefit from a 2nd PCSO.

COUNCIL HOUSING – PT stated that S Glos is currently considering the transfer of council housing. A number of land parcels are being considered, possibly even sites in this area.
