ILR spoke of the background to this application and previous activities at the site.  
RG informed those present that because the application was in progress no officer of  
S Glos was able to attend. The public were asked for their comments. It was soon  
obvious that none present supported the application, or, if they did, none voiced their  
opinions.

ILR confirmed that submitting the list of names of those attending, together with the  
Council response, would serve no useful purpose. It is important that each person  
submits their own response in order that their opinions are counted. Some of those  
present sought advice on the points they could make. In particular it was felt that  
Green Belt and Flood issues were insufficient on their own. Council had printed  
copies of a response that could be used, in which several points of issue are raised.  
Many present have produced their own letters in response but some members of  
the public took advantage of the service, which includes delivery to Thornbury.

With the time now 6.55 pm and the council meeting due to commence at 7.00 pm,  
ILR thanked everyone for their attendance and brought an end to the meeting.
