3 Minutes of the previous Parish Council Meeting

The minutes of the previous Parish Council Meeting held on the 4th May 2021 The minutes were unanimously approved as a true record.

Note another possible source of grant funding has been identified.

New Cemetery Gate has been installed and looks very good.

<u>Audit of bins</u> this has been carried out with one or two on the promenade needing to be confirmed.

<u>Cleaning of the War Memorial</u> the Clerk has corresponded with HR and a member of the public regarding a volunteer risk assessment for the work. No further news

<u>Limited governance review</u> the Clerk has prepared a map of the internal boundaries and circulated it to Councillors.

<u>Barriers at Bristol Road Bridge</u> The Clerk has corresponded with Mark King at South Gloucestershire Council. The situation is reviewed every five years with Network Rail. The last review was in 2017, since which time electrification has come through. If the higher kerbs are installed then the footpath will need to be raised and therefore the parapet of the bridge raised even further. South Gloucestershire Council are going to ask Network Rail to bring the joint review forward to this year to reassess this bridge and other structures.

The 10-strong Neighbourhood Plan Steering Group met on 22 June. They were joined by two observers - Phil Hall (Chair of Almondsbury PC) and Kate Royston (Director at SevernNet). A significant advance has been made with the grant application for £10,000. This funding will be used on publicising the Neighbourhood Plan and running residents' surveys.

We enjoyed several thought-provoking presentations, which emphasised the Group's ability to influence the shape of the local landscape by capitalising on the local community assets and realising the area's potential without causing irreversible damage to the environment. A debate was held about shaping up the Plan and how to overcome the limitations imposed on the group by various organisations.

The focus of the next few weeks will be resolving administrative issues in connection with the receipt of the grant, as well as setting the groundwork for the forthcoming surveys. Olga Taylor

Cemetery meeting June 8th, 2021.

First impressions were disappointing as it appeared to have been a few weeks since the grass had been cut.

The Clerk contacted the contractor the next day and it was done straight away.

Christmas Decorations have been removed and most glass bottles and vases have been taken away.

Further work is required to tidy graves in both cemeteries The Cemetery Clerk will contact the grave owners. She will ask them to start to think about reducing the amount of grave furniture further quoting regulations and safety.

Cemetery Clerk will contact a stone mason who will hopefully meet up with the Cemetery committee to suggest a way looking forwards. Some new graves need topped up (Some from 2014). We need to grass seed or turf those in the new cemetery that are ready for this and some in the old cemetery which have been sinking. Some of the older graves that are no longer looked after would benefit from proper grassing over which would reduce weeds and let the mower do a better cut. We need to think who would be best placed to do this.

It is felt that the Cemetery Committee should meet with the Stone Mason and hopefully address the issue of a Masonry Audit. We aim to have audited at least half of the Cemetery by next year. The split in the tarmac path needs to be addressed. It was suggested to contact the person who did the job to come back and repair it before it gets worse.

The two Saturday working parties were successful.

We need to arrange for some of the older graves that have been filled with gravel to have weed killer put on them. The benches need cleaning.

There are issues that need to be addressed that will incur a financial outlay.

A meeting to be arranged with Cemetery Committee JE and PT to discuss contracts for grass cutting. Some areas need to be identified for weed control.

Resolved the Clerk to organise a meeting.

Letters of thanks to be sent to volunteers of the working Parties. **Resolved SCB to pass detail to the Clerk.**

The Church path is in a poor state. Clerk to contact South Glos with a view to repairing it especially as the PC has replaced the railings. Not easy to move a trolley with a coffin smoothly. PT requested that we ask for the bridge to be inspected given that it is nearly 50 years old.
