6. PUBLIC PARTICIPATION

Colin Brickell voiced his concerns regarding the activities at Xander Park, Church Road, Pilning, where XP Wood Recycling are disposing of the mountains of wood stored at the site. ILR has involved planning enforcement, following their admission that activities are contrary to the permission granted. It seems that Sam Phelps, son of the owner, has admitted that the water soaking process has broken down. Despite this the procedure has continued. Mr Brickell and other residents have been subjected to dust clouds. The 'toxicity' of the fall-out was questioned. Mr Brickell expressed the hope the nuisance could be brought to a rapid end.

6. PUBLIC PARTICIPATION (cont)

Chris Smith spoke on behalf of the Emmaus group and John Miller thanked council for their donation, agreed prior to his arrival.

7. AGENDA

7 – 1 Local Major Developments

Based on comment by NAC, Clerk registered an objection to this application. This is not aimed at the diversion as such, but more to the chosen route – in close proximity to the motorway.

7 - 2 Village Halls/Playing Fields

IWH has now obtained 3 quotes for relaying the tarmac at Pilning VH. All 3 quotes were fairly close but on the basis of being able to carry out the work during the school holiday, provided contact be made tomorrow (1.FCAB, 2 MDP, all agreed), AT were chosen to carry out the work. This quote includes extending the new tarmac area to the new tarmac at the school gate. Wooden edging could be utilised for a further £2035. 5 For, 3 Against (FCAB, NAC, CEW), 1 Abstained (IWH) a proposal that work be carried out without utilising wooden edging.

7 - 3 Diamond Jubilee Celebrations

FCAB is coordinating the teddy display on behalf of the parish council. It was agreed that members should respond individually to the invitation to attend the civic service. Saturday 26th May is designated as the day for distribution of the commemorative mugs. Both schools are unwilling to take on this responsibility as mugs are not being provided for the 30 pupils who are not parish residents.

Agreed the donation of £200 to St Peter's Church should be matched by a similar sum for the Emmaus Chapel "Big Lunch" project. On the same basis, and, due to reluctance by some members to sanction payment for fireworks - 'money going up in smoke!' – it was agreed the Scout request for match funding (£500) could not be met. A donation of £200, equal to those for the church groups will be made. Scouts are also to be asked about their insurance cover and requested that they notify adjacent householders of their plans.

7 - 4 Village Matters

Clerk – ILR asked for comment on the clerk advert. Agreed the post should be advertised in *The Gazette*, in the *In View* magazine and on parish notice boards.

Bus Services, Shelters & Signs – IWH commented on the erratic nature of the local services. The 624 service (9 am), operating on Tuesday, Wednesday and Friday, is sometimes failing to materialise. NAC also commented on the 'regularity' with which the 625 service runs 10 minutes late. It appears the ticket machine is invariably out of operation – somewhat reminiscent of the antics of the rail operators when they were claiming lack of use and trying to facilitate an end to the service. It is rumoured the service may reduced from 1 per hour to 1 per 2 hours. It was also indicated that rail services are regularly being cancelled or curtailed. IWH questioned the need for 4 Towns Transport to impose a £5 annual charge on those using the service. He recommended an increase in the allowance paid to the Care for the Elderly group. 1. IWH, 2 FCAB, all agreed, the fee be increased from £1 to £2.

Building-New Developments-Housing – ILR queried activity at Northworthy Farm. Have we seen a planning application? ILR also commented on the visit to Ableton Court. It appears the most likely outcome is the demolition of this perfectly serviceable building, with the consequent loss of local accommodation for the elderly, and its replacement with starter homes, maybe 13 in number.

Roads/Road Signs – FCAB again asked for re-surfacing in Beach Road. The missing Keens Grove sign has already been notified to S Glos.

Footpaths – ILR reported on his attendance at the committee meeting to consider the future of the Bank Road path. He was surprised to find those who opposed outnumbered those who were for. When he mentioned those who were against the claim it caused some disquiet among members. ILR urged a further council response and extra support from other interested parties.

Allotments – NAC commented on the need for a toilet at Pilning. ILR confirmed that chemical toilets are usually supplied on a lease agreement. Clerk confirmed that purchase of such a facility would cost in the region of £3,000.

Grass Cutting – In respect of the 2 quotes to cut the area adjacent to the Gorse Cover Road – Beach Avenue footpath, the Clerk recommended retention of the services of Gibbs GM. Members chose to award the contract to Mike Fisher, who is already contracted to cut all other areas in the parish.

7 – 5 Reports

S GLOS – RCG confirmed that 28 (chipped) horses have been returned to their rightful owners, though 22 mares were found to be in-foal, so the problem is hardly diminished. MDP reports up to 50 horses in the Minors Farm area. Bailiffs have posted notices warning that horses will be removed. This has resulted in some animals disappearing from the area.

STREET FURNITURE & LIGHTING – Lights are now being extinguished overnight (12 midnight to 5 am) on the M4, junctions 20-22, and on the M48, around junction 1.
