PRESENTATION FROM HINKLEY CONNECT PROJECT

The Parish Council were given a presentation by Gillian Burnell (Project Communications Manager) and Bruce Lockyer (Project Engineer) from the Hinkley Connection Project team. Details included an overview of the project to link Hinkley Power Station with Seabank for onward distribution. This project will involve replacing existing sections of high voltage line, some new lines and underground cabling.

At Seabank it will be necessary to undertake piling for a week and there will be need for temporary traffic lights on Severn Road whilst the work is underway.

Where trees need to be replanted this will be done on a one to four basis, every tree removed being replaced by four.

<u>Access roads on Severn Road Hallen</u> - Given the response from the South Glos officer; the Clerk has reported the possible contravention to South Gloucestershire Planning Enforcement ref no COM/21/0912/OD. Information also forwarded to Phil Hall at Almondsbury Parish Council. <u>Queen's Platinum Jubilee</u> – The Chair asked the fire authority regarding regulations about the bonfire and proximity to the motorway at one of the possible sites. PT will chase up a response on this matter. The Grant application was submitted to South Gloucestershire Council before the deadline. Thanks to SCB & HR for their work on this.

7 Public Participation

<u>Severn Beach Village Hall new windows</u> – The Parish Council were thanked by the committee for the grant to replace the windows. A further request was made to replace the exterior door. Although the Parish Council are agreeable to the approach it was declined. This is until the hall committee have the agreement of the South Gloucestershire Council building inspector that the door will meet exit regulations.

8 AGENDA ITEMS

.1 To decide on a course of action over the future of Pilning Village Hall

Report from the last Pilning Village Hall Management Committee meeting was received by the Parish Council. There were three members present at that meeting and no one initially in the chair. CW offered to chair the meeting on a temporary basis which was accepted. CW was left with the feeling that she was not being permitted to chair the meeting as she expected and as a result resigned as Chair and from the committee the next day. Concerns were expressed about

- the paper-based booking system not computerised.
- That there appears to be little progress in tackling any of the outstanding jobs that are required to be done. This is in part down to the small number of active volunteers.
- The expectation of groups using the hall to attend the Management Committee meetings is not being honoured.
- Rates for the hall are very haphazard.
- The Management Committee is barely quorate and recruiting new Management Committee members appears to be virtually impossible. Adverts in In View have not brought anyone forward.
- The hall needs a great deal of money spending on it, issues with the drains, toilets and roof.

The Clerk noted that the current management committee would need to be given the opportunity to dissolve itself with proper notice of an AGM. In effect closing the hall in the hope that a fresh committee will take it on.

Another option is that the Parish Council takes on Pilning Village Hall as "Sole Trustee" on a corporate basis. This does raise the question of Councillors keeping their charitable activities distinct from normal Parish matters.

West of England Rural Network could be approached for advice on this matter.

SCB suggested a meeting is held between the Parish Council and the Management Committee to start helping the committee out.

Landmark Environmental Consultants PT contacted; they have stated they have a conflict of interest. The Pegasus Group have been approached to see if they will be able to assist with this work. 9 The Neighbourhood Plan

Update on the last meeting 16th November from Richard Edwards (RE) (Chair of Neighbourhood Plan Steering Group)

- Attended by seven Steering Group members and Stewart Todd South Gloucestershire Council planning consultant via Zoom.
- There is a predicted underspend of the grant, at the January meeting a decision will be taken as to how the remaining grant will be reallocated, according to guidance, or returned.
- The survey was agreed to be launched; it went online from the 17th November and by 1533 paper copies to each household on the 18th November. To date there have been 233 replies just over 15%, the steering group are still hoping to reach the 30% target by the close of the survey on the 20th December. Those who have not filled in the survey were encouraged to complete it online via the Parish Council website.
- A subgroup will be set up to look at the next stage of the survey to engage with businesses organisations and groups of all sizes in the parish.
- Housing needs assessment report, specialist accommodation units have been identified for thirty to forty elderly residents. The final report is expected later this month.

- Identification of sites South Gloucestershire Council planning consultant gave useful advice on this subject and for the future direction of the Neighbourhood Plan. A first draft of the list of sites with associated map has been prepared and will be developed further over time.
- Next meeting is scheduled for 14th December 2021.

RE was asked if there was provision for traveller sites in the Neighbourhood Plan, the resident was told that the Housing Needs Assessment dealt with this subject.

Observations from Richard Edwards as Chair of the Neighbourhood Plan Steering Group

- Steering Group resources are limited and there is a struggle to get Steering Group members to complete the work. Things are going to get busier with the project in the coming months and the Chair wants to encourage everyone to commit to the project.
- Some criticism had been expressed to the Neighbourhood Plan Chair that ideas and comments were ignored in the production of the Parish Survey. However, all comments were considered by the survey subgroup members.

16 Report from S. Glos Council – please also see Appendix D

Cllr Griffin reported to the meeting that ahead of the next cabinet meeting there is no news on the M49 junction.

Two large amounts of asbestos were fly tipped in the ward and the cost for clearing this is in the region of \pounds 22,000. Fly tippers are aware that the locations involved are difficult to monitor with cameras. In other situations, cameras have been covered over before fly tipping takes place. Avon & Somerset Police have been made aware of these issues in this ward but resourcing constraints mean that little can be done to prevent it.

Cllr Griffin attended the Health Scrutiny Committee last week and was told about plans for two stroke units in thew region one at Southmead and another at possibly at Weston-super-Mare. He did point out to them that not getting patients out of ambulances quickly enough would be counterproductive and that should also be part of their focus.

He attended a presentation by YTL about the redevelopment of Filton airfield and the Brabazon hanger. It is going to be an enormous project lasting around thirty years including building 3500 units and creating another 10,000 jobs. By 2024 we can expect to see Filton North Platform being rebuilt and reopened. Probably not trains to Avonmouth but there could be services to Yate / Gloucester and to Filton Abbey Wood Bristol Temple Meads and Bath.

Finally, he paid tribute to local surgeries and pharmacies getting Covid and flu jabs into people's arms.

IFCA (Devon & Severn Inshore Fisheries and Conservation Authority) – I have had to resign from this excellent organisation for personal reasons as it consumes a full day a month in Devon. The low-speed rib of this organisation travels up to the Severn Bridge monthly to sample fish stock and water quality which are passed on to the Environment Agency. Currently things are good except for traces of phosphates in the water. This is attributed to agriculture wash off. I also gave my opinion that long range drones could be used. These could identify foreign trawlers inside our 12 mile limit.

Health Scrutiny – at last week's meeting the proposed future plans on stroke treatment were explained by the CCG. This consisted of one unit at Southmead and another located possibly at Weston-Super-Mare. The location to be confirmed. I asked the question as the A&E ambulance waiting times are now considerable, will these ambulances be checked for stroke patients so they can be treated within the critical timeframe. I was assured this is the current practise.

YTL - (Barbizon Complex) – I attended a presentation by this landowner on the next 30 years of construction for the site. The first phase of 3,500 units is under construction followed by other phases at regular intervals. 10,000 permanent industrial jobs are expected to be generated during this period. The Filton North platform is to be rebuilt as a full station by 2024. This will be on the Severn Beach line via the Hallen loop and Abbeywood station to Bath via Temple Meads. Eco friendly houses with modern insulation standards and solar panels are planned in traffic free precincts with cycle lanes. Shops, schools, parks and other amenities are planned.
