8 AGENDA ITEMS

.1 To decide on the display of painted pebbles

Notes from the 14th June meeting with the Centenary Working Group, Clerk and pebble painting organiser.

Money for the painted pebble display will come from the Hinkley Connection Hamper.

A variety of options will be considered by a Sub-committee of CW (lead), SCB, KW, MP & HR and then to liaise with pebble painting team.

.2 To decide on the donation of stone from BAM Nuttal

Still unknown how much stone may be available.

Resolved, If necessary, a meeting will need to be convened to decide on any stone donation between this meeting and the September meeting.

.3 To decide on grant to 1st Severn Beach Scouts re Platinum Jubilee

Papers circulated previously.

After much discussion the proposal for a grant was agreed to 1st Severn Beach Scouts of £300 in respect of the Jubilee Beacon event.

Action JE

.4 To decide on writing to Network Rail re issues accessing the Severn Tunnel from Green Lane

Papers circulated previously. The issue is that large vehicles are turning round in Gorse Cover Road to approach the turning on Green Lane from the Severn Beach end. This causes traffic to suddenly face a slow moving or stationary juggernaut when it is least expected.

Proposal to ask Network Rail about any risk assessment they have carried out on this manoeuvre and whether a turning triangle could be created on Network Rail's land to avoid this potentially dangerous method of working currently undertaken several times a year from happening in the future.

Papers circulated previously. One item not mentioned in the report was the railway foot level crossing at the Chittening end of the sea wall.

.6 To decide on a response to land raising issues on 1957 consent land

There are a variety of land raising issues on 1957 consent land.

- Unlawful raising (South of Severn Beach already being fought against)
- Proposed plot 2§ & 3
- Consented plot 4 contrary to planning policy

District Cllr Robert Griffin (RG) left the meeting

§ The developer of Plot 2 has applied for a Certificate of Lawfulness. However, Condition 9 of the 1957 consent (that the land should be kept in agricultural use) has not been complied with; meaning that the Certificate of Lawfulness cannot be granted without breaking planning law. ND has spoken with the planning officer and has the impression that the Officer could still go ahead and grant the Certificate anyway.

The Parish Council might find that a Judicial Review would be needed and should be prepared for that eventuality. ND proposed that the barrister who is currently looking at the Orchard Pools issue should be asked to provide a quote, considering the strength of the Parish Council's case. The timescale for a JR can be quite short and consequently the Parish Council might have to be ready to act quickly. If required an extraordinary meeting will need to be convened.

Noted that South Gloucestershire Council does not appear to be working for the best interests of the Parish.

11.1 Village Halls

11.1.1 Severn Beach Village Hall

CW reported that there was no meeting in June, next meeting will be end of July. Cancellation of the dongle at Severn Beach Village Hall in exchange for a cheaper hub.

Proposal and agreed unanimously to pay for the hub instead of the dongle.

11.1.2 Pilning Village Hall

Minutes circulated previously, SCB was pleased to report that there has been a good deal of progress on several projects.

- PVC soffits and facias are being cleaned this week
- Village Hall Committee are going to investigate funding new ceiling tiles
- Roof inspection undertaken and shown to be watertight.

11.1.3 To decide on new drainage system for Pilning Village Hall

SCB presented the case for replacing the drainage system at Pilning Village Hall. Ongoing issues with the drainage system are well known. Pilning Village Hall Management Committee have selected a quote from three possible contractors for consideration for funding by the Parish Council.

Vote to accept the quote from Andersons Drainage Solutions as per their estimate of 31st May 2022. Proposed KW and seconded MP agreed unanimously.

11.1.4 Pilning Playing Field

Looking tidy currently, there had been a concern over the grass cutting but that appears to have been dealt with.

SCB has been in contact with the Clerk with a view to getting the grass cut on the Rhine side of the car park. Village Hall Secretary to ask the Lower Severn Drainage to cut the bank as well.

Resolved to ask Tim Dark to strim this back all the way to the hall.

Construction and operation of two marine loading arms and a control kiosk at the Oil Basin in Avonmouth Docks to enable sea-going tankers to be unloaded, and engineering apparatus and pipework at the Avonmouth Gas Terminal, including two additional loading bays for road tankers, and associated infrastructure. Outline planning application with access and landscaping to be determined, all other matters reserved. Application to be read in conjunction with Bristol City Council planning application 21/04816/P. <u>P21/05372/RM</u> Plot 4 Land At Western Approach Severn Beach South Gloucestershire BS35 4JX Reserved Matters Application pursuant to condition 1 of planning permission ref. SG4244 (dated 27th November 1957) comprising the layout, design and external appearance of 1 no. commercial building (Use Class B8) including servicing arrangements, vehicle parking, landscaping, attenuation features and associated works. <u>Approve with Conditions</u>

<u>P22/02630/CLE</u> Annexe At Libette Church Road Severn Beach South Gloucestershire BS35 4PW Continued use of annexe as 1 no. independent dwelling (Class C3). <u>Approve Certificate of Lawfulness</u>.

<u>P21/07613/F</u> Land and Buildings at Libette Church Road Severn Beach South Gloucestershire BS35 4PW Demolition of 1 no. attached shed, 2 no. garages and 1 no. carport. Erection of single storey side and rear extensions with other associated works. <u>Approve with Conditions</u>.

.2 Update on ongoing planning matters inc. enforcements and applications.

Various South Gloucestershire Council planning including Shaft Road meeting coming up. Cllrs encouraged to get involved with the Parish Council response to the Master Plan. It is possible over the summer that several important planning applications will come up. PT will liaise with the Clerk regarding responses and attend meetings at South Gloucestershire Council if required.

.3 To decide on professional legal advice - ref Orchard Pools.

PT received a response from Environmental Law Foundation (ELF) to a reply from South Gloucestershire Council Enforcement.

SGC Enforcement realise that there is an application pending to discharge condition 1 of the 1957 permission for approval of layout, design and external appearance of Orchard Pools. South Gloucestershire Council officer goes on to claim that ELF were made aware of this in January. No consultation was received by the Parish Council regarding the discharge of condition 1. PT has responded to ELF to get more detail.

Following a virtual meeting between South Gloucestershire Council and the owners' agent, SGC are awaiting response on the legal agreement questions they raised regarding this matter. SGC have requested their legal department to instruct counsel to advise on the legal position relating to the various point relating both to the original position and the effect of the legal agreement on it. This is still subject to confirmation. Due to the shortage of legal support SGC apologises that this is taking longer than had been hoped.

Resolved for PT, ND and the Clerk to continue liaising with ELF and to keep councillors updated.

Road maintenance – Throughout the ward work is being carried out.

<u>Legal Sentencing Changes</u> – Judges in the cases of dangerous/careless driving causing death can now increase the penalty to life imprisonment. Also, serious injury/death to minors can result in a similar penalty.

GP shortage – there is a national shortage and our surgeries are also experiencing staffing problems but doing their best.

<u>Hospital Waiting lists</u> – over two years patients can be offered operations at a different area of the country with the NHS paying the expenses involved. 400 patients have elected for this option. <u>Benefit Recipients</u> - They will receive a cost-of-living payment from the 14^{th of} July of £326 and another in the autumn of £324. The Bank Rate increased to 1.25%.

Electric Cars – the allowance of £1,500 on these new cars has been removed.

G.P help - The signatories on medical sign off notes etc. has been extended to other medical professions. It is proposed that Pharmacists can now refer suspected cancer patients to consultants after tests.

NHS drugs – out of patent drugs can be replaced by generic versions which could save £1.5 billion over three years.

<u>Dame Deborah James</u> – After this brave young lady's Bowel Cancer death 23 million people are reviewing their Health status.

<u>Covid Ba.4 and Ba.5</u> – 2.3 million are currently suffering with this disease. Please ensure your vaccinations are up to date.

<u>MMR vaccinations</u> – children cover for these diseases has dropped to 40% which is danger level. <u>Public Houses</u> – The number of these licensed premises has dropped to below 40,000 which is the lowest ever.

<u>National Insurance changes</u> – from the 1^{st} of the month two million workers earning less than £12,570 will no longer pay this insurance. Also, employees earning less than £34,000 will contribute less.

<u>Centenary Celebration</u> – These are still going on as I write this, but sincere congratulations to all who organised these events which really helped to bring the community closer together. We are looking forward to the fete next week and hope the weather is kind. The local events continue in the autumn – flower shows etc. so much to look forward to locally after what has been trying times for everyone.

Appendix D - Report on Jubilee & Centenary Celebrations

Report back on summer events 2022

We started with the idea of celebrating first the Jubilee and then the village Centenary. At the outset we were determined that we were not going to run everything ourselves but be the facilitators and coordinators.

We had an extensive list of ideas, many of which we floated with others.

We set up the framework of an event each Saturday, leaving others, individuals and groups, to do their thing and add to the programme. The school similarly had a long list of ideas as to what they could do on their day. Inevitably the long lists of ideas depended on people coming forward to take them on.

The Centenary Beacon event attracted around 1000 people, so it was surprising and disappointing that so few people responded with other ideas for the centenary. I am not aware of any street-party having happened, or anything other than those items on the programme.

Thank you to Carol for making sure that the afternoon tea party happened on 6th June; and thank you to Mike for the graphics for the posters and flyers. The scarecrow/pirate idea generated sixteen entries in the parish.

The winners were located in in Salthouse Park who had not just made a pirate but a mermaid too and a runner up in Cranmoor Green with a lovely depiction of the Queen.

This was an opportunity to shake us all out of 'stay at home and avoid people' which the pandemic had forced us to adopt, and for this whole effort would bring people together as a community. I think we achieved that to some degree, but a lot will depend on what happens next. I believe that the Parish Councillors' role includes leading the development of community cohesion. Events, activities and clubs are the glue that hold the community together.

The Music in the Park was a great event, spoilt by the high winds which meant that many people didn't stay for long. In total perhaps 500 people attended, though no more than 200 at any one time. The Cars Day was also successful, with 20 classic cars and a bus on parade. This would certainly have been 30-40 vehicles had the weather forecast been better; and then the rain dump happening when it did, sent people to shelter and soaked the band. But a lot of people came out of their houses to watch the cavalcade, so it was good that we took the longer route around the village.

Both events could be repeated, with this year's learning benefiting a future one. But I am not suggesting that us three should be doing the work, we need to look to the next generation to take the lead and make things happen.

The village, the Parish, the Neighbourhood, needs events to bring the community together to generate its identity, so I hope we shall agree to support these events if we can find willing persons to take the ideas forward.
