3 Minutes of the previous Parish Council Meeting

The minutes of the previous Parish Council Meeting held on the 5th July 2021 The minutes were unanimously approved as a true record.

4 Matters arising

<u>BAM Nuttal</u> this meeting has now taken place with follow up conversations and emails.

<u>Gypsy plat signs</u> no update but SGC are due to put them up shortly. Cllrs asked to look out for them and inform the Clerk.

<u>Survey of waste and dog bins</u> the Clerk is in process of completing this survey. The Clerk to report back when it is completed.

<u>Cleaning the War Memorial</u>, it was reported that this work is still to be done. The Clerk mentioned the risk assessment he prepared and the need to create a safe space around the memorial for cleaning.

<u>Bullnosed kerbs at Bristol Road Bridge</u> a reply to Mark King to clarify where the kerbs are to be fitted.

Resolved to write to Mark King

<u>Severnside Siren</u> no update on the issue with siren number 8. PT had contacted the trust but is waiting for a reply. PT to contact again.

Hinkley presentation now scheduled for either November or December.

<u>Roy Edwardes Way</u>, sign ordered and agreement from St Peter's Church Council that the sign can be fitted to the church wall. Sign to be unveiled after the church service on Sunday October 3rd. <u>Additional dog waste bin on Gypsy Platt</u>, no contact from Cllrs following the last meeting. MP to ask the landowner if they will fund a bin. <u>Definitive Footpath requests</u> Cllrs have had some returns, some requests have been sent to SGC for processing. Work in progress.

<u>Wainbridge steps</u> The Clerk contacted SGC to obtain a key but has had no response. Confusing speed signs the additional sign on Ableton Lane has been removed.

<u>Repair to the bus stop</u> on Redwick Road, despite the appeal for information about anyone hitting the bus stop nothing has been received by the Clerk. Shaun Blackburn confirmed that the post cannot be bent back. Cost is £1276 inc VAT

Proposal to get the bus shelter repaired

Five for and two abstentions motion carried.

Action JE

<u>Request to SGC to resurface Church path / Roy Edwardes Way</u> Mark King will get someone to assess the path. The last four inspections have revealed no specific defects. However, they will assess it for resurfacing. From Cross Hands Road to bridge there is a significant slope to the path and through the cemetery there are tree roots damaging the surface.

<u>Bridge over the rhine</u> SGC asset register 58009 due for inspection in 2023, the last inspection did not find any defect. Consideration will be given by SGC to its slippery surface.

<u>Pilning traffic calming</u> The Clerk has contacted Mark King for an update and was told that the work should be undertaken at the end of August.

<u>Pump track project</u> MP has two contractors to look at the potential site of the pump track. All councillors and Clerk are invited to attend that meeting. MP asked to contact the person who started the idea going to give them an update.

<u>Water point</u> The Clerk has contacted Bristol Water; they are unlikely to be interested as all the water points are exclusively in Bristol.

Letter to South Gloucestershire Council regarding "The Island" The Clerk has had a reply from Mark Seabrook at South Gloucestershire Council stating he will be in touch once he has spoken to Highways England (now National Highways). Note the person that was dealing with this matter at NH has now left.

<u>Speed bump height at Jackson Close</u> SGC to check it for height, email 03/08/2021 stated that the table has been measured and are within specification. Assurances were given by SGC that all the cushions would be 75mm in height.

Cemetery tidy up the volunteers have been thanked and the Cllrs present were thanked.

<u>Smell at Northwick Cemetery</u> the Clerk visited with a South Gloucestershire Council Environmental Health officer. A possible cause might be a neighbouring cess tank in need of attention. Previous evidence of grey water being put into the ditch has been removed. Issue has been referred to Building Control to ensure that a proper waste treatment plant is installed under P21/00264/F. <u>VAS Camera</u> the camera offered by Olveston Parish Council is no longer available. Cllrs are looking to investigate a pole mounted camera for the parish.

5 Correspondence

<u>Electric train</u> the first electric train under test has stopped at Pilning to check on board information systems.

<u>Possible increase in road traffic</u> concern raised by a resident that after M49 J1 is opened there will be an increase in people using the village as a cut through. Particularly J1 to Cribbs Causeway could be an issue. The resident suggest that current data is collected to use to compare against future changes.

Resolved to be raised at the joint meeting between South Glos and Parish Councils

Possibility that a new speed camera could be used to record the number of vehicles passing. **Resolved to ask South Gloucestershire Council to undertake a traffic survey now.**

Note the access onto the B4055 at Marsh Common Road will be for any vehicle, however South Gloucestershire Council can impose a weight restriction if required once it is built.

<u>Sea Wall height</u> a resident trying to get concerns raised with South Gloucestershire Council regarding the sea wall height. PT or a volunteer from the Council suggested to attend a Full South Glos Council meeting.

Resolved that a Councillor attends a full council meeting to raise the issue further Action PT

District Councillor's report RG had been contacted by one of the senior Councillors regarding planning application P21/01529/F Land to The South of Church Road. This application will now be referred to the planning committee enabling Parish Councillors to make the case against the

proposal.

Regarding a car park at Severn Beach station that all available budgets have been reallocated to tackle the pandemic and only schemes funded by Parish Councils are currently proceeding.

PT noted that this missed the point, if you have a willing developer who can create the required infrastructure then a compulsory purchase order could be granted. This can be used to encourage the current owner to develop the land or for the land to be purchased and a new developer to do the work.

Resolved for PT to talk to the relevant cabinet member at South Gloucestershire Council

The Clerk reminded the Councillors that training courses are available and encouraged them to make use of them.

One Councillor is undertaking ALCA two courses at £30 each, the Clerk is also undertaking training towards CiLCA accreditation £410.

.7 To decide on a response to South Gloucestershire Council regarding outstanding projects

A list was sent previously regarding highways projects to South Gloucestershire Council detailing issues in this parish.

Resolved that the list is refreshed and be resubmitted to SGC.

.8 To decide on repairs to Northwick Tower window jamb

The Chairman has a contact with a qualified structural engineer who will assess the work with his stonemason.

Resolved to be discussed at the October meeting

Note funding for the restoration of the rest of the tower is being sought from grant giving bodies.

.9 To decide on paying for explanatory plaques obtained by the Local History Group

It was explained that these plaques for the marker stones re-erected on the Binn wall by Salthouse Farm. The history Group are requesting financial assistance of £168.48 in getting the signs and for help with putting them up.

Proposed that the cost of the signs is supported by the Council All agreed

Clerk to ask Tim Dark to assist as required.

9 The Neighbourhood Plan

The meeting was updated on the progress of the Neighbourhood Plan Project. Cllr Graham was thanked for her work on the latest newsletter.

The Neighbourhood Plan Steering Group were delighted with the responses they had at the Severn Beach Craft Fair. The group were pleased that many visitors to the stand knew about the Neighbourhood Plan already. The registration of interest form is available on the Parish Council website for anyone wanting to take part https://www.psbpc.co.uk/neighbourhood-plan The draft Housing Needs Assessment is now available to read, the Clerk has sent a link to Councillors previously.

The Neighbourhood Plan Steering Group were thanked for an excellent stand at the fair on Saturday.

10 Severn Beach Centenary

PT updated the meeting that a meeting had taken place with Severn Beach Primary School Head and another meeting is planned for a few weeks' time. It is envisaged that the overall event will be centred around children, marking the centenary but looking to the future. Events are expected to take place between the Queen's Platinum Jubilee and the Severn Vale Festival (9th July 2022). PT to provide a list of all the events being planned. These include

11.1.3 Pilning Playing Field

Damage to the wooden fort. The recent inspection has revealed more damage, Tim Dark has been asked to make it safe. The Clerk asked that the equipment should be fenced off until repairs are undertaken.

It was noted that Severn Beach play equipment gets very little vandalism as there is someone who overlooks the equipment and is willing to challenge any issues. Worst offenders are adults misusing the equipment rather than children. It is regretted that Pilning Playing Field does not have that sort of cover from an interested neighbour. Ouestion was raised should the Parish Council consider putting CCTV up to protect the play equipment?

Volunteer asked to investigate obtaining CCTV

If the Council does go down the route of installing CCTV the Clerk has a draft policy that can be used.

11.2.1 Severn Beach Allotments

Numbers 8, 16 and 29 are now let again. Most of the allotments are looking good with only a few struggling. The Clerk confirmed that there are four or five people on the waiting list for either Pilning or Severn Beach allotments.

11.2.2 Pilning Allotments

Inspection by SCB and HR of the allotments, these were looking good, still plenty of produce waiting to be harvested. There did not seem to be any problems that they could see. Plot 3 at Pilning is now vacant and is now spilt to 3a and 3b, Clerk is in contact with the next people on the waiting list.

Quote received from Shaun Blackburn for the allotment / new cemetery fence for £2000.

11.3.1 Pilning Cemetery

Inspection by SCB and HR Grass had been cut recently and most of the area was looking tidy. The Cemetery Committee have been unable to meet but are hoping to schedule a meeting before the end of September to discuss the grass cutting contracts which will be due for tender soon.

During our brief time at the cemetery two residents were each exercising two dogs off leads in the new cemetery. Two were running around out of control but when approached said they had been doing it for years and everybody did.

16 Report from S. Glos Councillor Robert Griffin

The only things I have to report are that First will resume pre-pandemic services if the passenger numbers recover to former levels.

Likewise, WECA has cancelled some subsidised bus routes and reduced others due to budgetary restrictions since the pandemic.

P21/01529/F – I had a phone call from Adrian Rush about this application. I said I couldn't see any entries on the Planning App and that's why I turned it down.

He asked if he could investigate it on my behalf. I was happy for him to do so and then I would talk with Planning. The Member's Referral form must be signed by the

Ward Member as a pre-requisite of Planning.

Severn Beach Car Park – I spoke with Steve Reade on this topic. He said the request I made to Cabinet in November 2019 was still on-going. Since then the pandemic has occurred and all unspent committee budgets with the exception of Education & Health & Care had been re-allocated to support the virus.

Currently the District Council like many others in the country is in negative dire straits and under national law cannot spend. It is hoped the Chancellor will allocate more money to councils in the October Budget or it will take until 2023/24 to resume normal expenditure. Only car parks financed by Parish Councils are progressing.
