3 Minutes of the previous Parish Council Meeting

The minutes of the previous Parish Council Meeting held on the 6th May 2025 were unanimously approved as a true record and signed by the Chair.

56/876 – Severn Beach train noise – MP asked GWR about the continued usage of class 166 units on the Severn Beach line and whether class 175's could be deployed. GWR are looking at battery electric traction, but this is not likely to be implemented until the 2030's. Suggested that MP meets with Claire Young MP to encourage government and GWR further.

144/854 – Broad Gauge rail display – Timbers are on the concrete plinth, not yet set up; Clerk has had wording approved by the Local History Group for the interpretation board. Design to be finalised by LHG. Work to resume once better weather arrives. Clerk has chased PT and Local History Group. LHG is busy on producing their next publication.

150/56 – Flooding preparedness exhibition – Almondsbury, Aust & Oldbury on Severn are keen to make a joint approach to South Gloucestershire Council. Clerk to contact South Gloucestershire Council to start the process. Sean Rhodes agreed to ask the relevant officer. Update requested from S Rhodes. Clerk to chase Sean Rhodes about this again.

10 WORKING GROUPS

.1 Community and Green Spaces Working Group

SR presented the report from the inaugural Community and Green Spaces Working Group.

Severn Beach allotments

Severn Beach allotment fence – Consideration was given to the erecting of an allotment fence, SR reported that the allotment holders present at the working group meeting thought that a fence was unnecessary, although the subject will be kept under review.

Water troughs / standpipes - Most people that have contacted SR weren't in favour of installing standpipes, they weren't deemed necessary. Some of the current water troughs

are leaning and leaking water due to rotted wood underneath, which needs repair. ND offered a solution to fix the uneven water troughs.

163/537 Action ND

Parking concerns – changes to the height restrictor gate and difficulties locking it and people leaving it open. ND noted that when the height restrictor gate is moved it should be easier to operate.

Tenancy agreement update – It was felt at the working group that tenancy agreements need to be updated.

Severn Beach Allotment Association – plans are coming together to re-establish an allotment association at Severn Beach.

Severn Beach allotment entrance – a request was made to see if the long grass at the allotment entrance could be mown.

Water pumps - see agenda item 11.2

Pilning allotments

Bank Road boundary trees and hedges – these need to be attended to as allotment plots are being overshadowed. SR to get quotes for the work. See item 10.2

Skip – A request for a skip was mentioned at Pilning allotments. The Clerk mentioned this is not something that is done at this site. Rubbish should be taken home as per the tenancy agreement, as it also should be at Severn Beach.

Willow – The plot with the willow in it will be dealt with in November, a contractor is already lined up to do that work. It's already been trimmed back hard. Note the allotment plot still has a paid-up tenant.

Promenade Gardens - Planting at the gardens SR reported that South Gloucestershire Council are still working through the grant applications, which were oversubscribed.

Northwick Road footpath – there are times when the path from Pilning Surgery to the top of the old railway bridge has become completely impassible. PT noted that there are a number of places in the parish that South Gloucestershire Council need to be nagged to get them maintained, this is one of them.

No mow May – there wasn't a great desire at the working group meeting to see areas of No mow May extended. Dog fouling being one of the main issues. Also having to scarify ground to prepare it for wildflowers was felt to outweigh the benefit.

Future topics – PT mentioned that the Green Spaces WG could consider looking at are Local Climate and Nature Action Plan (LCNAP) South Gloucestershire Council Climate & Nature Group.

Frances Barr Walk Hedgerow Control – also a topic that the WG could consider addressing. SR noted that conversations had already taken place.

The Parish Council were pleased to hear OT's report that the remaining platform at Pilning Station has been completely resurfaced, new fencing has been installed, smartening up the area no end. Pilning Station group continues with its campaign of getting more services to stop at Pilning Station.

.8 To receive a report from the Cemetery Clerk

Following the tragic death of a four-year-old child due to an unsecured gravestone in Rawtenstall Cemetery, attention has turned to headstone safety. Regular "topple tests" are conducted. Unstable headstones, note some of the graves in the old cemetery are over one

hundred years old are (if required) respectfully laid flat. When grave owners can't be contacted, the Parish Council steps in to fund the laying down and landscaping work to remove hazards. The Parish Council has a webpage listing affected graves and contact details for the Cemetery Clerk.

Concerns were also raised about contractors allegedly being paid to top up graves but failing to do so. Issues around grave decorations such as bark or stones complicate topping up efforts and cause procedural delays. These matters may need to be addressed by the Green Spaces Working Group as part of implementing the grave decoration policy.

Appendix C NPSG Report

Neighbourhood Plan Steering Group (NPSG) Report to Parish Council 7th July 2025 – delivered by Richard Edwards

Since our last report for the PC meeting on 6th May, the NPSG has had meetings on 13th May and 17th June.

Matters discussed at the Steering Group meetings and arising since are as follows:

Level 2 Strategic Flood Risk Assessment

After further rounds of correspondence to address the Steering Group's comments, the final version of the SFRA was received from JBA consulting on Friday 10th June. This has been sent to AECOM to complete their technical work, and shared with both SGC and the EA for information.

Neighbourhood Development Plan

Considerable effort has been put into editing the document, such that it was fit to be sent to AECOM to undertake their technical work. Once we can include the results from the SEA, HRA and Evaluation of Sites

reports we will address the final changes identified in our comments log. The document will then receive legal compliance checks from our consultant and SGC ready for it to be used in public consultation.

SEA, HRA and Evaluation of Sites. These technical pieces of work have all re-started. Originally estimated to take 6 weeks, we are now not expecting to receive the final reports until mid-August.

Communication with Landowners/Developers

For all potential sites in the NDP, the Steering Group has written to all, including the Parish Council, to advise on progress and to ask for any information supporting SEA or HRA.

Regulation 14 Consultation

We anticipate this important stage will commence in mid-September and must run for 6 weeks. It will include making the NDP and all supporting documents publicly available. Informing all statutory bodies including the PC of the consultation. Communicating the consultation with the public and businesses within the community with drop-in public events. Feedback received will be captured and considered before the NDP is formally submitted by the PC to SGC for examination around the end of October.

Funding.

You may have heard the recent government announcement that their funding for Neighbourhood Planning is to cease? Already commenced technical work we have ongoing like the AECOM activities will be supported. We had thought the monies agreed with Locality in the last financial year would be available to us, but now understand this is not the case. This means we may struggle with payment of the SFRA work, further work for consultants, preparation of materials for Regulation 14 consultation and the booking of halls and meeting rooms. After 4 1/2 years effort and having finished 90% of the NP, it is vital that we find the funding to allow completion. We are investigating alternative sources nationally with help from Locality but may also need to do this regionally or locally. The situation must be highly disappointing for those communities starting out on NPs.

Other Consultation and Planning

On the Local Plan we have had exchanges with SGC on two topics; the Strategic Led Masterplan for Severnside and the spine road. We have responded to the SGC consultation on EV charging points in Severn

Beach. We have submitted supporting comments to the planning application for the miniature railway on Promenade Gardens.

Next SG meeting: 15th July, 7pm at Emmaus Church.

Appendix D Unitary Councillor Report

Key updates for Parish Council colleagues in July 2025.

- Work to construct the M49 junction has now started. South Gloucestershire Council has successfully secured the land ownership needed and the land transfer completed during late June. The site compound has now been established, and the team are setting up the compound on site which is superb to see after many years of delays and slow progress. Claire Young MP and I visited the site ahead of work starting.
- Funding has been secured within the Council to resurface the roads through Easter Compton, Pilning & Severn Beach this autumn. Residents have sought support to upgrade the local roads, fix potholes and improve road markings. This work will take place later this year and it should be noted there will be disruption during the works which we hope to mitigate as much as feasible – I will share the final scope with the Parish Council to liaise on any final points with Streetcare before the work starts.
- Electric car charging is being proposed installed on Station Road in Severn Beach by South Gloucestershire Council. This is part of the Council's commitment to becoming carbon neutral by 2030. Plans and details have been shared with the Parish Council.
- On the back of resident concerns, I have taken photos and shared my request with the Council for the road surface and markings to be improved on Beach Rd outside the Morrisons store. The road is heavily worn, and markings are difficult to see, often meaning driveways are blocked and rights of way unclear.
- The West of England Combined Authority (WECA) has expanded its e-bike and e-scooter trial across South Gloucestershire and partner authorities nearby. Despite my request to South Glos and WECA officers my ambition to include Severn Beach hasn't been fruitful. I will continue to push for this as connecting more people into Severnside / Seven Beach station remains a focus.
- Enforcement Officers have provided an update (attached) relating to the ongoing enforcement at Pilning Station. This includes a history of the enforcement on the site, including the new enforcement notice ref. COM/22/0222/OD/4 was issued in late June 2025 for the additional areas for the Land behind Pilning Station.
- Due to the retrospective applications for the land raising for both sites still being determined, references P25/00342/F and P25/00343/F, the planning enforcement team took the decision to issue enforcement notices against both developments on 4th June. The notices require all imported materials to be removed and the sites restored to their former condition.

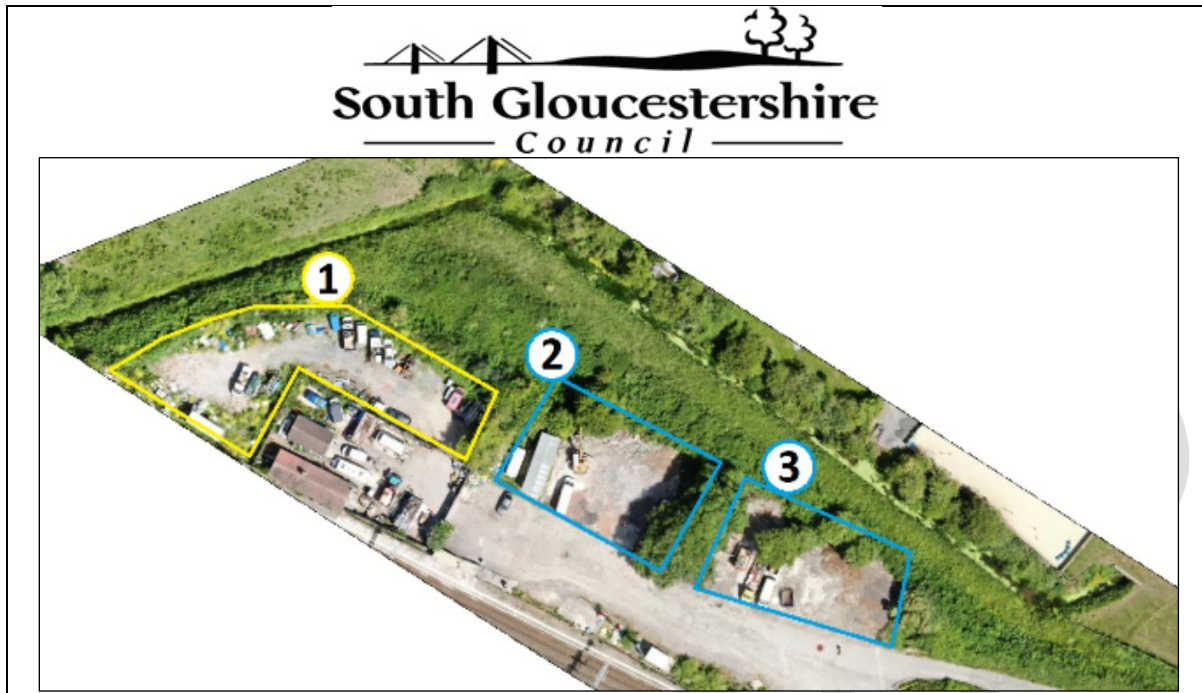
The decision to issue the notices was taken as it was considered the timeframe for immunity of the developments was close. The issuing of the notices has thus 'stopped the clock' in planning terms and prevents the developments from becoming lawful through the passage of time whilst the applications continue to be determined.

The notices take effect on 3rd June 2026 in order for the current applications to be determined, with a compliance period of six months from that date if no appeal is lodged beforehand.

The planning enforcement team will consider their position once the applications have been determined.

- I have raised resident concerns about speed and weight limit infringements throughout PSB. This is a very regular occurrence, and Avon & Somerset are not (yet) fully able to react and enforce these scenarios locally. This is not in PSB alone, I had similar feedback from Councillors elsewhere in South Gloucestershire and recently met with Officers and Councillors in Bristol regarding speeding through Hallen into Bristol. There are wider frustrations being seen about the lack of enforcement. I am planning a meeting with SGC Road Safety team to at least let residents know what we can do to support their concerns.
- The WECA Mayor has confirmed the funding for 918 bus route for another year which is welcomed following the mayoral election and successful lobbying by local parents, children and Council colleagues.
- In my wider role for South Glos Council as Cabinet Member I've attended the Health & Wellbeing Board strategy workshop this month, along with Chairing the Corporate Parenting Board for children in our care, attended the Wessex Regional Flood and Coastal Committee and attended a visit to John Cabot Academy in Kingswood as part of a youth consultation exercise.
- Following a late-night incident and altercation during June in Severn Beach, I have liaised with concerned residents in Beach Road and continue to work with Avon & Somerset Police to understand what had taken place. This appears to be the second occasion a disturbance and incident has been reported and Officers have now visited the home to find out more. At this stage I can't provide additional details and I'm aware Cllr Davies has spoken to Officers to help their investigation.
- The proposed model railway scheme is progressing through the South Glos Council planning process, enabling detailed plans to be assessed by the Officers, provide assurance to environmental concerns and importantly for local people to have their input in a fair and transparent manner. I look forward to the conclusion of the process and await the outcome which we'll share as soon as its known, thank you to all those involved who aim to provide a valuable community asset – I'm aware of some additional planning and planning enforcement questions relating to the adjacent allotment site, and I'm meeting internally with Officers to understand these concerns in more detail this week or next.
- Children from St Peter's School wrote to me during June, seeking the provision of a new bin in the ward. Thank you to the Parish Council for taking this request and following up with the teachers and children who I know will be pleased to see action.
- I've remained in contact with the resident's group at Salthouse Farm Park. They have also liaised with Claire Young MP relating to the owners of the site as we look to ensure the site runs and fulfils its obligations to people living here in Severn Beach.
- I'm awaiting further updates on planning enforcement matters relating to a number of sites in ward, and will update the Parish Council, when possible, with information I can share.

COM/22/0222/OD/3 – Enforcement notice (EN) was issued for area 1 (as per image 2 above), ‘Without planning permission, the change of use of land from agricultural to storage, and associated development including ground works, laying of hardcore, and the creation of a bund’.

This notice was issued on 19 July 2023, the requirements are,

1. Permanently cease all non-agricultural use of the land.
2. Permanently and completely cease all storage use of the land.
3. Remove all associated engineering operations on the land which are facilitating the change of use. This includes, but is not limited to, all hardstandings, bunds, and alteration of ground levels.
4. Remove all items dumped or stored on the land in association with the use.

In July 2024, aerials show that the storage use and hardstanding in area 1 had been reduced but not reduced fully. However, by March 2025 aerials show it had increased again. The next step will be to contact the site owners and if required begin prosecution proceedings.

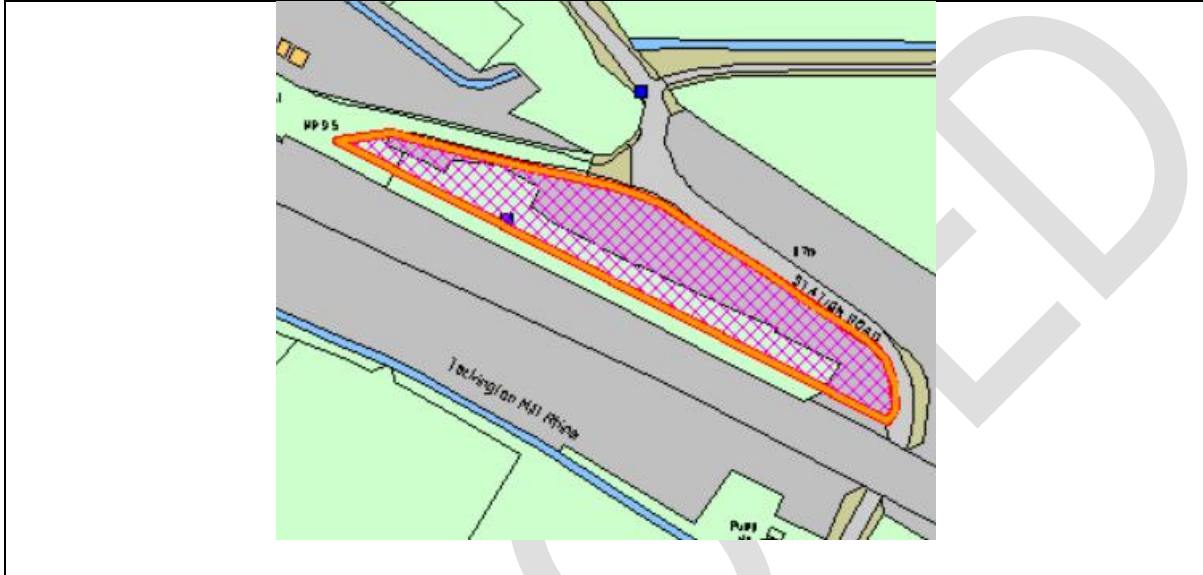
COM/22/0222/OD/4 – On May 27 2025, our Investigator visited the site and noted the use of the additional areas 2 and 3 (as per image 2 above).

A new enforcement notice has been issued for, ‘Without planning permission, operation development consisting of ground works (regrading of land) and the laying of hardcore in the areas identified as 2 and 3 on Appendix Image A attached to this notice’.

This notice requires,

1. Remove the hardstanding and all imported materials identified in areas 2 and 3 on Appendix Image A attached to this notice.
2. Return the ground to its original condition before the breach occurred as shown in appendix Image B, including but not limited to reinstating the land to its previous levels.

It was served on all relevant parties on 19 June 2025 and comes into effect on 23 July, with a compliance period of 1 month.



COM/22/0156/COU/2 – Enforcement notice was issued for Without planning permission, the change of use of land from a nil use to storage.

This notice was issued on 13 December 2023, the requirements are,

1. Permanently and completely cease the use of the land for storage.
2. Permanently and completely remove all materials from the land associated with the use. For the avoidance of doubt this includes, but is not limited to, the skips and materials stored within them, vehicles, and the portacabin type structure to the East of the site.
3. Return the land to its condition prior to the breach occurring.

In July 2024, aerials show that the items had been removed from the land, but some remained.

On May 27 2025, our Investigator visited the site and noted the site was still being used for storage and therefore they would be in breach of the notice for the land identified in the above notice.

When I visited the site on the 19 June for the adjacent site, there was a large number of vehicles there for the station works and they were using the land adjacent to the tracks for their materials and the removed platform etc.

The next step will be to contact the site owners and if required begin prosecution proceedings.
