

Pilning & Severn Beach Parish Council Meeting held on Monday 1st September 2025. Emmaus Church Centre, Gorse Cover Road, Severn Beach BS35 4NP 7pm

PRESENTATION FROM GASREC REGARDING "PLOT 9000" DEVELOPMENT

Gasrec's Chief Commercial Officer James Westcott outlined the company's plans to install a biomethane refuelling station for HGVs, highlighting environmental benefits and operational details.

Councillors and members of the public raised concerns including:

- Site location relative to the M49 access, a location nearer to the junction would be preferable to residents.
- Traffic volumes (500 vehicles/day). It was explained these would be vehicles already going to Western Approach already, it wouldn't generate additional traffic.
- Light pollution and environmental impact. Care will be taken in the planning process not to cause excessive light pollution.
- Safety of above-ground fuel tanks. An explanation was given regarding why the gas storage tanks are above ground, namely that they would be considerably more dangerous if buried.
- Lack of clarity on full site usage, Gasrec are leasing only part of the site, the rest of the site may be used for EV charging by another company.
- Historical promises regarding non-development of the area, residents made the point that the land had been safeguarded for nature in 1995/6 and any development was very unwelcome.
- Engagement with local operators (e.g., Amazon, Royal Mail). Gasrec are working towards getting these big firms interested in using their facilities

Gasrec committed to sharing slides and further information via a dedicated webpage.

The Maintenance and Facilities Working Group has been making good progress across the parish. Several jobs have already been completed, including repairing benches, installing new litter bins in Pilning and Severn Beach, repainting the teen hut, and finishing emergency roof and arch repairs at Northwick Tower.

Other projects are still ongoing, such as coordinating volunteer litter picking, putting QR codes on war memorials and in cemeteries, improving disabled and coastal path access, and working with the Coastguard on better entry points. Some items, such as cemetery signage and traffic consultations, are being passed to other working groups for follow-up.

Overall, steady progress is being made, with several important community improvements already in place and others moving forward.

Appendix E NPSG Report

Neighbourhood Plan Steering Group (NPSG) Report to Parish Council 1st September 2025 – delivered by Richard Edwards

Since our last report for the PC meeting on 7th July, the NPSG has had meetings on 15th July and 12th and 19th August.

Matters discussed at the Steering Group meetings and arising since are as follows:

This has been an extremely busy period for the Steering Group.

AECOM Site Assessment Report.

We received this ahead of schedule on 1st August. We've returned a comments sheet identifying a good number of errors, and amendments required, several of which are around how they are continuing to report issues around Green Belt, which you may remember was an issue back in 2023. We have adopted content from the draft report into the Neighbourhood Development Plan.

AECOM HRA and SEA Reports.

We have now received draft copies of both of these reports. The quality appears to be good and we've returned just a few comments for amendment. There are no significant implications for the NP. We've again adopted content from the draft reports into the Neighbourhood Development Plan.

Neighbourhood Development Plan

Much work has gone into the document and it's now looking like the finished article. Work has included a thorough and helpful review from our consultant Stuart Miles. Yesterday, the document was sent to SGC who will complete a pre-Regulation 14 compliance check this week. Should there be a need for amendments these will be made next week so the document is ready for release for Regulation 14 consultation.

Regulation 14 Consultation

This will run for 6 weeks from 15th September through to 26th October. There will be public drop-ins here on 18th September and at Mafeking Hall Pilning on 20th September. Notification has appeared in In View, we will email all on our correspondence list, contact businesses groups and organisations around the Parish, and present at a SevernNet business meeting. We have a list from SGC of the statutory bodies we must notify, which of course will include SGC and the Parish Council.

The Steering Group will analyse and as appropriate address all feedback received during the consultation period. We do hope the overall benefits for the community are appreciated and any responses will identify a healthy level of support for the Neighbourhood Plan.

Funding

With the Government having stopped funding, the Steering Group continues to explore avenues to allow us to complete the Neighbourhood Plan. So far, our approaches to our MP and SGC have proven fruitless, with no positive responses and often silence. We have discovered SGC's own funding for their work in delivering Neighbourhood Plans has been stopped. It remains to be seen how they will manage independent examination and referendum, for which they are legally obliged.

Planning

The Steering Group has attended and made representations at the site visits of the planning committee on 22nd August to two sites on Bank Road. The intention is to attend and speak again at the Planning Committee meeting at Kingswood later this week.

Next Meeting

Apart from the two drop-in sessions later this month the Steering Group has no requirement or plans to hold further public meetings.

Appendix F Unitary Councillor Report

Key updates for Parish Council colleagues in September.

This report may be shorter than previous reports given the summer holiday period, a lack of Officers within the Council due to school holidays / annual leave, and my own time away.

- I visited the new site compound as the M49 junction work takes shape. With the tarmac compound in place, supplies are arriving on site. The initial work will redirect the existing cycle path and install piling alongside the pond adjacent to the new link road. The area has all now been cleared which is great to see. Conversations with Severn Net and local businesses remain ongoing to limit disruption but also ensure safety in the area.
- Formal Council communication will shortly begin to arrive with residents throughout Pilning relating to the large resurfacing scheme planned for the villages. This will be transformative, finally upgrading local roads for local people, but will cause some significant disruption when done. As soon as the full information is available, we will share it as widely possible. The planned schedule can be seen below;
- 1. Whitehouse Lane to Vicarage Road 1st 8th October 2025
- 2. Vicarage Road to The Glebe 9th 21st October 2025
- 3. The Glebe to Wainbridge Crescent 22nd 29th October 2025
- 4. Wainbridge Crescent to Northwick Road 30th October 11th November 2025
- I met this week with the Parish Council as we look to progress the planning applications linked to the Promenade Gardens in Severn Beach. Both the model railway and man shed / car park are continuing to progress, albeit slower than hoped. We are planning a site visit with planning officers to finalise both applications for consideration. The Officer leading the application process is on leave until early September, but this remains a priority.
- Last month I shared my objection to the planning application concerning the Northwick Landfill site this has been a dormant site for many years and now has a thriving eco-system in place that should not (in my opinion) be disturbed given the uncertainty of what's held underneath.
- It was extremely sad to learn of a fatal road collision in the ward on the A403. My thoughts are very much with the family of the young person who sadly lost their life travelling on the road. Following shared concerns with the Parish, I am liaising with South Glos Council road safety colleagues to better understand what led to this collision, and how we can mitigate and make changes to the road to ensure it never happens again.
- I've returned from holiday to see lots of positively intended patriotism this month, with flags flying across South Glos, and here in Pilning & Severn Beach. Those supporting the women's England Rugby World Cup team and those displaying flags on their own property are lovely. Sadly I have been made aware of verbal abuse being directed towards local people 'cleaning up' poorly installed flags in public spaces that have turned into litter issues, and had videos and photos shared of children being sent up ladders in the dark on busy main roads to install flags with Sellotape and zip ties to lamp posts. As someone who works nationally and internationally in sport, I'm very aware of the power and importance of identity and belonging, and will happily champion this right, but it shouldn't ever be done at the expense of anyone else.

- Progress to address concerns about weight limits, speed limits and road safety have not progressed over the summer. This remains a priority, I'm very aware of the need to enforce people breaking the rules locally and endangering lives. This relies on a great working relationship with Avon & Somerset Police which is currently undergoing a lot of change, but I'm hopeful we will see support and help to address this ongoing issue.
- WECA are developing an economic strategy for the region, led by the Mayor Helen Godwin. This plan looks across WECA for economic growth opportunities, and includes the area along the Severn Estuary, including Severnside. I have met with, and fed back on the importance of Severnside, and the need for the commercial benefits to align with the neighbourhood plan and local needs of people living here.
- Hopefully residents are aware of the new South Glos Council app you can download it now to receive updates relating to SGC, including bin collection days, push notification reminders and a range of other services will be added to the app. We're trying to make communication easier and enable residents to do more in the app as it can be hard to navigate the Council website at the best of times.
