7b Report from Kelvin Packer Principal Project Manager (M49 J1)

Mr Packer (KP) was appointed by South Gloucestershire Council in March 2022 to oversee the design and construction of the link roads.

Current Priorities

- Land agreements, securing pieces of land for the link road.
- Initial design work reviewed and new design work undertaken.
- Topographical survey of the site,
- Geotechnical advice, particular care needs to be taken with settlement of the natural clay and the pond at the Amazon site.

Future work

- Acknowledgement that communication is required and South Gloucestershire Council is developing a joint communications plan with National Highways (NH).
 - Dedicated email address for any enquiries
 - o Dedicate web page on the South Gloucestershire Council website for timely updates
 - o Regular meetings and events for parishioners when key milestones are reached.
- Money for the project has been secured from Dept for Transport. South Gloucestershire Council and National Highways are finalising the mechanism for drawing the down the funds.
- Detailed designs being worked up
- Draft Land Agreements to be issued to Landowners.

Timescale

- Based on the review being undertaken
 - o land transaction and consents will be completed in 12 months.
 - o twelve months to build the link road, giving time for any settlement issues.
 - o The expected completion date is Summer 2024.

Question asked

• Will the extra damage to local roads be addressed because the junction is not being open sooner?

- Not in the remit of this project.
- Does a Geophysical survey already exist for the site?
 - o There is a previous topographical survey, but land levels appear to have changed...
- Was there a topographical survey from National Highways?
 - o Not as part of the 'As built' drawings to KP's knowledge.
- Will the scheme see the adoption of the spine road?
 - Plans are in being developed to get this developer funded work completed. Note the link road will not be made into a dual carriageway.
- Will the scheme see the spine road opening towards Severn Road (Hallen)?
 - o This is in the scope of the overall work to connect to the new motorway junction.
- Will the cycle path be available throughout the works and be properly completed?
 - This is in the scope of work.
- The Parish Council requests an update in two to three months
 - KP happy to come to a future meeting to give relevant updates

9. The Neighbourhood Plan

9.1 Update

Last NPSG meeting was held on 19th April

Strategic Infrastructure-led Masterplan for Severnside

We had a face-to-face meeting on 8th April to supply SGC & Atkins with detailed information on status and direction of the Neighbourhood Plan, verbally and documented. Very positive meeting, await their draft and further engagement in late May/June.

Steering Group Membership

Penny Riches and Robert Goard have completed their applications to become member and will be voted in at our next meeting. PT removed from the membership of SG – he participates in an ex-officio capacity.

Steering Group ToR

Following the receipt of feedback on Issue 3 of the ToR from the Parish Council on 4th April, the document was amended and circulated as a draft Issue 4 prior to the meeting. The changes were discussed and approved at meeting.

Finance

Expenditure at the end of year was £2,962.59. We have therefore returned to Locality £7,037.41 of our £10k grant.

Locality has now reopened for 2022/2023 grant applications. We will determine our grant re- application at our next meeting.

Criteria for additional grant funding (£8K) regarding housing has changed - only applies where rented social housing is included and not just affordable housing for sale.

Survey of Businesses, Organisations and Groups

The SG is progressing well with its approaches, with the aim of completing by mid-May. However, the approaches to large businesses on Severnside only happened today. SevernNet, received the letter to distribute on 6th April.

Parish Character Assessment

Sub-group met on 26th April, 7 attended. Identified 13 different areas for assessment in Pilning and 16 for SB. Mike Harrison is mapping these out on Google Earth. We have the criteria to focus on and will share out responsibilities shortly.

Design Codes Study

Visit arranged for 11th May Simon Hargreaves of Aecom to tour the Parish.

Review of the Project Plan

Draft Issue 4 prepared reflecting status at end of financial year and an approximate two month slip in programme. To be finalised with forward plan at our next meeting.

Future SG meetings agreed to start at 7:30pm.

NPSG has been invited to present at an open bike marking event on 14th May at Pilning Village Hall.

A SGC flood risk consultation has come to light. We have responded with request for making NPSG input.

Next SG meeting 17th May.

9.2 Amendments noted to version 4 Terms of Reference, Neighbourhood Plan team thanked for their continued work.

10 Severn Beach Centenary / Jubilee

SCB previously circulated a list of events for the jubilee and centenary. Councillors asked to share the information as widely as possible.

Most of the events initially planned are coming to fruition.

<u>Pebble painting</u> – a potential location for a permanent display would be on the slope behind the tea cottage. Work in progress.

<u>Posters & flyers</u> – these are being produced for residents.

<u>Information for schools</u> – both St Peter's School and Severn Beach School will be sending out messages to parents about activities, particularly pebble painting.

Tea towels – these are now on sale in Severn Beach at £5 each.

Sticks of Rock – these will be available from w/c 8th May.

<u>Publicity</u> – Advertising through Radio Bristol and Bristol Post, media people are getting involved. Jubilee Benches – have been delivered and are waiting to be fitted.

<u>Jubilee Hamper</u> - this item has been ordered via Hinkley Connection. The prize is under £500 and tickets for the raffle will only be sold on the day. Therefore, this will not be subject to lottery licencing laws.

<u>Jubilee "torches"</u> – HR displayed a handicraft torch made from carboard tube and crape paper to make the flame effect.

<u>Lighting the beacon</u> – The Queen's Pagentmaster has suggested a later time for the beacon to be lit. At this stage it is be too late to be changed.

<u>Contributions & donation</u> – a number of these are coming in now to help defray the cost of the event.

<u>Jubilee sport grant donation</u> – poor response to the appeal for ideas. SCB is in contact with the donor to discuss this further.

News for Pilning, Severn Beach, Easter Compton & Hallen. May 2022

Dear Ward Members,

McColls – With the reduced opening hours and the removal of Post Offices services from Severn Beach and possibly Easter Compton, I have had discussions with staff about the shop and their future. I have offered any help and requested to be informed of any activities. It would appear this national group was under offer but there have been solvency problems.

Blackhorse Hill - in the past, I campaigned and got a financial allocation from South Glos. for a pathway from the top of Blackhorse Hill to the village opposite the zoo. With the event of the Wild Place a commitment to Planning was made that when their numbers reach a certain threshold set by the zoo it will provide a pathway on their land. This commitment is still active and hence South Glos. removed their allocation for financial help.

Traveller' site Bank Road, Pilning – A certificate of lawfulness is coming up for renewal. Road repairs/upgrades – These are being carried out on advice from the Highways ultrasonic inspections which are checked out regularly. Most of our roads in my ward have no foundations and have been laid on anhydrous clay, which due to changing conditions, is breaking up.

Hallen Traffic Calming – being brought to the fore again after more observations. Unfortunately, this is a classic case of a narrow road being used by HGVs and building work.

Riverside Park, Severn Beach - I have had requests for the grass to be cut and the boundary fence removed from the north section of sea wall extension. I have been informed the building work will be completed by the summer.

Four Towns Community Transport – after losing 13 minibuses due to a malicious fire the community has helped keep the service going. Many thanks and congratulations to all concerned.
