# **LOW FREQUENCY NOISE POLLUTION - REPORTING ISSUES**

South Gloucestershire Council Environmental Health Department continue to work in partnership with the Environment Agency (EA) to resolve the issue. As the EA regulates the incinerator via an Environmental Permit, the residents can report any disturbance (this also includes flies or odour from the incinerator) on their 24-hour pollution number - 0800 80 70 60.

Your feedback has been recorded, analysed and passed on to the decision makers at South Gloucestershire Council.

## **CCTV AT SEVERN BEACH RAILWAY STATION**

British Transport Police attended Severn Beach station after report of vandalism to the shelter. The BTP were impressed with the quality of the CCTV images produced by the recently installed equipment – this enabled them to identify the suspects and start the proceedings.

# ST THOMAS'S TOWER, NORTHWICK

At our November meeting, the Parish Council Clerk was pleased to report that a progress has been made with an application to secure a grant with The Pilgrim Trust for the repairs of Northwick Tower. It is not a straight-forward process, and there is a lot of hard work ahead. The Parish Council are aware that St Thomas's Tower is considered a treasured local landmark by many parishioners, and we very much respect their point of view that the Tower should remain in public ownership, whilst being adequately maintained.
