APPENDIX D Neighbourhood Plan Steering Group

NP SG Report to Parish Council 3rd April 2023 SG meeting since last PC meeting: 14th March. Matters discussed and arising since.

Public Presentations:

Much time has been taken of late with the preparation and delivery of the two public presentation events on 28th March at Emmaus Church, and 1st April at Mafeking. These included draft vision, objectives and policies, technical support completed, project timelines and maps showing potential sites. Both events were well attended by the public. Despite a few concerns from residents living close to potential sites, e.g., the clearing of the railway sidings in Severn Beach, residents were in general positive about the draft objectives and policies drafted in the Neighbourhood Development Plan. Attendance also included a good representation from Parish Councillors.

Evaluation of Sites:

The situation of AECOM wanting to deviate from the agreed approach of excluding flood risk and green belt from the evaluation of individual sites remains. The Steering Group has met with SGC who support the original approach. This is now left with Locality to resolve. In the meantime, the NPSG will progress with further evaluation of the sites themselves using the interim findings of AECOM as the basis. A sub-group meeting for that is arranged for 6th April. In the meeting with SGC it was agreed in principle that Sequential Testing should be based on the Parish area. Although the Local Plan is scheduled for completion after the NP, SGC indicated it could include 'hooks' to address some manoeuvrability with green belt in the area.

Next SG meeting 18th April
