Prior to the commencement of the meeting Mr Moore signed the Declaration of Acceptance of Office Book. GM confirmed that he had agreed to take on the duties of JM only in respect of the Public Transport, Finance and SB VH committees.

Timings for the 614 service every Friday were provided for NC. NC confirmed that the service, specified as a Hail and Ride, was not satisfactory. A 12 seater mini bus is used and users are required to book in advance. This hardly conforms with the requirements of a public service. PT is to take up the matter with Four Towns Transport.

Re the new shelter at the Burger Bar, the successor to Mr Darlow (now retired) has been appraised of the need to provide hard standing for the shelter and road markings to prevent parking by other vehicles.

PT has been in contact with Sue Luton to progress the provision of allotments at SB. Clerk has written to the allotment occupant who was criticised for the lack of activity. No response has been received, but some work has now been done at the site.

No confirmation was received from Insp Corrigan on methods of making contact with PC Lodge. MP stated his personal opinion of the inadequacies shown by PC Lodge. Agreed to ask Insp Corrigan for a meeting, to discuss this and other problems. Also noted, Community Officer Ray Barlow is currently on extended sick leave.

#### 7 – 2 Village Halls/Playing Fields

DH stated that the Fire Brigade was called to a fire set in a 'den' in the hedgerow on the eastern boundary of the field. He expressed regret that the fire had not been allowed to run its course. One tender had attempted to gain access along Gipsies Plat, only to find the fixed bollards prevented entry. The 2<sup>nd</sup> tender had simply driven across the field. There was some discussion on the possibility of replacing the fixed bollards with lockable/removable ones. These, however, had not proved to be successful prior to the installation of the current fixed variety, although access for maintenance vehicles is certainly curtailed under the present system. Agreed this is a matter for the footpaths authority to deal with.

#### 7 – 3 Naming of Footpaths & Bridleways

AG proposed that names, where known, should be used for the footpath routes. NC agreed that she could certainly recognise a path when referred to by name, whilst mention of the footpath number meant absolutely nothing to her. MP suggested that name plates might simply encourage further vandalism, but AG countered by stating that the possible threat of vandalism should not deter the council from its chosen course of action. Proposed AG, seconded DH, all agreed, that naming of routes could be both helpful and aesthetically pleasing. PT indicated that a programme of sign mounting could be funded by S Glos to the extent of 50%.

#### 7 – 4 Cemetery/Churches

Members discussed the content of the letter from the Rev Dr Berj Topalian, relating to the future of Trinity Hall. Agreed to contact Rev Topalian for a meeting to discuss the likely expense involved. Any decision by council would depend on the information received.

#### 7 – 5 A403

The 'yard' at the end of Church Road, adjacent to A403, where retrospective permission was granted for timber cutting, has now been converted to use as a lorry park. Following approaches by local residents the Clerk has already contacted Enforcement, informing them of the apparent transfer of the timber operation to Deane House Farm. Contact to be made with Enforcement in regard to the 'lorry park'.

#### 7 – 6 Village Matters

**Travellers** – NC confirmed that the Hearne family is now 'officially' in residence in Bank Road, a number of children having been enrolled in play school. Agreed Clerk should contact S Glos requesting that conditions regarding occupation should be enforced.

**River Pill** – Problems have been noted with the rhine to the north of Cross Hands Road and to the rear of the properties. Raw sewage was noted and the Drainage Board informed. Initially refusing to attend, expanding upon the full circumstances of the situation caused a change of heart, and the Board investigated the matter.

**State Pension Service** – AG reported that Mark Baker, representing the service, is to hold a surgery at SB post office, on 3<sup>rd</sup> January, and subsequently on the first Tuesday each month. Sarah Roberts of S Glos has volunteered her services to assist with form-filling.



**Shaft Road** – MP drew attention to the un-repaired fence and gate. Clerk has already written twice, but will again contact the Environment Agency.

**Ableton Lane/A403 Junction** – CW drew attention to the poor quality of street lighting at this junction, a problem that has been raised with S Glos on more than one occasion. PT has informed S Glos and the problem has been identified on the list of outstanding tasks, although it is currently not a high priority.

**Finance Meeting** – Arranged for Monday 19<sup>th</sup> December at the ICI Club, commencing at 7.00 pm.

**December Council Meeting** – Originally scheduled for Monday 5<sup>th</sup> December, due to the absence of DH and IH, the meeting has been re-arranged for Monday 12<sup>th</sup> December, commencing at 7.00 pm. The current meeting is the last of those scheduled for a 7.00 pm start. Proposed CW, all agreed, that meetings continue to run at this earlier time.

#### 7 – 10 Reports

**PUBLIC MEETING** – Generally it was felt the meeting did not achieve anything satisfactory. Officers present had agreed the need to meet again. There would appear to be little point in identifying the council's position as opposite to the consensus identified at the meeting. PT suggested that writing to suggest that we were awaiting a S Glos update on the proposals would put the onus on them to make the next step.

CW mentioned the idea of setting up community speed groups. AG informed members the neighbourhood watch, in tandem with community officer Ray Barlow, had been considering a training course for this very purpose. This idea has been delayed due to Ray's illness.

**MOTORWAY VERGES** - PT informed members that work by the Highways Agency, whilst appearing to be drastic, would be compensated for with new planting designed to replace missing and damaged trees.

**ST PETERS CHURCH** – PT, with some councillors, attended the 150<sup>th</sup> anniversary service at the church.

**PUBLIC MEETING @ EASTER COMPTON** – IH, along with 200 others, attended the meeting organised to discuss the zoo proposals, which include the provision of a roundabout at the top of Blackhorse Hill. IH suggested using the other route into the lane, a route which the proposers were completely unaware of, but will now be looking into.
