GRAVE DECORATION POLICY

This diversion already causes walkers to cross the busy A403 in two locations, both of which feel very unsafe. We are looking to get in touch with the contractors and South Gloucestershire Council to see if a better solution can be found.

GOVERNMENT CONSULTATION – FUTURE OF TRANSPORT: RURAL STRATEGY

How would you like to improve our rural transport network that connects Pilning, Severn Beach and nearby towns and villages? What about a wider solution



across the county, the former Avon authority, and the South West? Do you think we need a service to Thornbury, Bristol, Chepstow, Newport or Cardiff, or a fast route into London? Do we want to see bike or electric scooter rentals in Redwick or New Passage? Do we need electric car charging points?
