#### NORTHWICK TOWER UPDATE

Thank you to everyone who shared their thoughts on the future of Northwick Tower. We hear your concerns about the plans to sell it privately. From the feedback that we received we concluded that the local community would prefer if the tower stayed in public ownership. Everyone understands that money is tight at the moment, and that it won't be easy to find funding for the preservation of this historic monument. Nevertheless, the Parish Council are still pursuing various avenues in search of funding, to make sure that we fulfil our duty of representing view of the local people. We will provide interim updates, but the final decision will have to be made at the next Annual Parish Meeting.

#### **ROAD LAYOUT IMPROVEMENTS IN CHURCH LANE**



As you can see from these two images, the path into the bridge between Pilning and Severn Beach (Church Lane) has been improved after an unfortunate accident that involved a motorised scooter. We are grateful

to South Gloucestershire Council for finally fixing the problem, and we hope that in future the Council will be more proactive in their response to the Parish Council's requests, thus avoiding

unnecessary incidents. An improvement was also made to the Church Lane where it joins the A403, to serve the development site. The fly in the ointment is that we were under impression that the gate was going to be moved forward, so that stopping vehicles would stay in full view. As this has not happened, there are some concerns that the new layout might encourage fly-tipping. Let us remain vigilant!



#### **PILNING RAILWAY STATION**

In June an application was made for the Restoring Your Railway 'Ideas Fund', which was set up by the Department for Transport (DfT) with a view to hear ideas for reopening lines and stations closed in the past. The DfT acknowledged acceptance of the Pilning application, which was supported by Jack Lopresti MP, and confirmed that their decision will be announced at the end of the summer.
