Mrs. J. Elliott was welcomed as a new Councillor and signed the Acceptance of Office Book.

- 367 <u>DETACHED BUNGALOW</u>, WAINBRIDGE APPLICATION.

  This application refused by the Planning Office.
- 416 SOIL DUMP, PILNING.
  The Glos. County Council have this matter under examination.
- 511 NORTHWICK CHURCH.

  The Church Commissioners have been informed the Parish Council is a Burial Authority.
- 521 PLAY LEADERSHIP.

  Councillor Edwards was given a letter received which gave details of sports equipment obtainable. He will deal with information given.
- 528 LOCAL GOVERNMENT REORGANISATION.

  Councillors had fears that in the transference of the Parish from Gloucestershire into Avon the Parish might become grouped with Avonmouth and their powers neutralised. They wished to be assured that they would remain grouped with Thornbury R.D.C.
- SEVERN BEACH, VILLAGE HALL.

  Mr. Petch wishes a meeting to be held in his Office, regarding a possible loan to the Hall Committee. Councillor Denner stated that following this meeting, he would arrange a meeting with Miss Walker at Gloucester to discuss the obtaining of grants.
- 543 <u>LITTER BINS.</u>

  The Councillors agreed to order 1 large and 6 small bins for use in the parish.
- 555 STAGNANT WATER, DITCH NEAR SEVERNWOOD GARDENS.

  The nuisance of flies and other insects, and smells arising are considered a health hazard, and the public Health Officer is to be approached. Councillor Ball stated the "levels" of the ditch was a contributory factor.
- 567 STORAGE AREA. OSBORNE ROAD.

  This has become an eyesore, with an accumulation of various rubbish.

  An attempt to get this cleared is to be made.
- 574 SEWAGE PLANT, REDWICK ESTATE.

  The R.D.C. will level the depressions, seed the site and repair fencing along Pill rhine.
- 581 KERBING OPPOSITE PILNING GARAGE.

  Councillors felt the kerbing had done away with the congestion by vehicles, and the painting of "YELLOW" lines was unnecessary. The Police Chief Inspector was having a watch kept on the area.
- CARS ON RIVER SEVERN EMBANKACHT.

  It was resolved to ask the Highways Surveyor to arrange a meeting on the site.

- A gap left in the construction of the pavement is the cause of a complaint and considered a danger. The Highways Authority is to be pressed to complete the whole length.
- 607 DOG NUISANCES AND FOULING OF PAVEMENTS.

  The price and sizes of metal warning notices are to be obtained from Glos. C.C.
- 608 MARSH COMMON VERGE.

  The Drainage Board Engineer is to be asked to level the spoil taken from the rhine now it has dried out.
- 614 TERMINAL 'BUS STOP, SEVERNWOOD GARDENS.

  The 'Bus Co. will investigate removal to the site suggested by the Council.

  PLOTS OF LAND FOR PRIVATE HOUSE BUILDING.

  Glos. C.C. have no scheme or proposal to provide such land.

  The R.D.C. are to be asked if they do or propose to do so.
- TREE PLANTING.

  Thirteen trees have so far been planted and compliments on this have been made by members of the public. Tree Guards and labels have not been received and suppliers are to be asked to do this.
- 620 BEND IN ROAD, MARSH COMMON.

  "CHEVRON" signs have been ordered by the Highways Surveyor and will be erected upon receipt.
- 'BUS SERVICE FOR NORTHWICK.

  The 'Bus Co. states a limited service is possible, but it would have to be agreed by Glos. C.C. and their grant to the 'Bus Co. increased accordingly. The County Council is to be approached.

  The 'Bus Co. regretted not having advised the Parish Council of the new 'Bus Service schedules, but would do so in future.
- 628 CAMPING GROUND, SHOP, TOILETS ETC. APPLICATION.

  Application was made by the tenants of Severn Beach Hotel, for a site at rear of the hotel. Councillors did not object to application provided it was "Seasonable Only" and that the usual amenities found on a camping site were provided.
- 631 CEMETERY COMMITTEE REPORT.

  This report was accepted, no objections were raised to any item put forward.
  - PLANNING COMMITTEE REPORT.

    This report was accepted with one objection. Some Councillors strongly opposed item "E" and children collecting rubbish, as a grave danger to them.
- 63 O.A.P. COMMITTEE REPORT.

  Flashing lights had been installed and buzzers will soon be completed. A Chiropody Service is being arranged, also a prescription collecting service is in operation. An Advisory service is now set up. Councillor Snell was thanked for this valuable work done.
- EMPTY BAGS, ABLETON LANE.

  Empty cement bags apparently from the Wimpey development of Parklands are in the ditch opposite. The development manager is to be asked to remove the bags.
- 633 PARISH COUNCILS LIAISON COMMITTEE.

  Councillor Parsons reported 9 favourable replies received. He
  was appointed as the Council's delegate to a mid-May meeting at Thornbury.
- OSBORNE ROAD 'DUMPED' RUBBISH.
