Currently, he does not have available time to meet with us. • Old play equipment at Pilning removed but fence still there because of bark. Fence will be removed by Nick Davies. • New play equipment ordered to replace above. MP has not taken it any further but it was discussed that his place of employment should be contacted. MP to provide details of the employer to VB and then VB to contact to complain about the inconsiderate parking. • The 20mph limit was proposed by MP and seconded by TF. 2 were for and 8 against. PT said there was no point as it is not enforceable. Instead, it was agreed the 30 mph sign to be moved from outside Crossing House. Proposed by PT and seconded by KW, all in favour. • A meeting was held with SB School and Community Library there is not an option due to class size. North Somerset Mobile Library would cost £750.00 a year for three stops. There is no tie-in for 3 years, as previously thought. PT said that we should agree for a year and see how it goes. HR suggested that we could look into commercially sponsoring a more permanent library from local businesses. SCB said that sponsorship was not necessary and the PC should pay for it for the community.
