Finance Committee Meeting

Held on 19th December at ICI Club. Minutes, estimates and proposals were issued to all members on 24th December. IH briefly reported on the meeting, expanding upon proposals for increasing payments to the Clerk and the logic behind this. No one wishing to comment, it was proposed AG, seconded MP, all agreed, that all proposals be accepted.

Accordingly a precept request will be submitted to South Glos for the sum of £50,000. As figures are accepted unchanged, they have not been re-issued. Those published as Appendices I - III to the December minutes to suffice.

6. PUBLIC PARTICIPATION

Mr Gary Sheppard of Passage House, New Passage Road, spoke with members regarding an application for construction of an earth bund to the southern side of New Passage Road. Council informed S Glos they saw “no good reason why this application should not be granted”. However, as the application has been referred to committee and the comment has been interpreted merely as a ‘no objection’, Mr Sheppard queried the council’s position, asking whether it might be possible for a more positive note to be injected. Original proposals for the second Severn crossing project included the construction of a bund. As with many other proposals, the provision of the bund was delayed. Finally, responsibilities were shirked. Following claims that no funding was available, the bund never materialised. Agreed that council would fully support Mr Sheppard in this matter. *Clerk faxed Mrs Butt (the case officer) the following day, - receipt confirmed- copies to Mr Sheppard and PT (a committee member)*

7. AGENDA

7 – 1 Severnside Development

CW again drew attention to the intolerable noise levels created by bikers. Environmental Officers at South Glos are now involved and it appears that a meeting will be organised with Gazeley, the landowners, and also involving the Police. Members also informed that biker activity had been noted in the area where travellers had previously caused problems.

Attention was drawn to PT05/3568/RVC which seeks the variation of condition 4(a) – limitation on floor space area - imposed on application PT01/0293/RVC at Western Approach. As this will provide *carte blanche* for excessive development of the site, agreed the application be opposed.

7 – 2 Village Halls/Playing Fields

SB VH have requested funding for improvements to the changing facilities at the hall. It was noted that funding for this year has already been provided in full. Any funding provided will need to be properly allocated between the field and hall funds. DH to inform committee that funding will only be available against next year’s precept.

DH left the meeting at this point.

7 – 3 Village Matters

Northwick Road - SC again complained of the quality of the fencing at the bridge. Agreed to contact South Glos in order to request improvements.

Roads/Road Signs – NC indicated that the sign at the junction of Redwick Road/Vicarage Road, indicating “Keens Grove/Chessell Avenue”, is in need of resetting.

Police – MP stated that a number of complaints had been received regarding speeding along Beach Avenue. Hodges transport lorries are the culprits. Speeding is a Police matter, and they are to be informed.

Footpaths – AG mentioned that signs at the A403 end of Gipsies Plat, warning against motorcycle use, did not exist at the Church Road end. To be rectified.

Local Facilities & Amenties – AG stated Mark Baker, representing the State Pension Service, had been pleased with his first surgery. Next attendance- 7th February.

Village Halls – MH is disgusted by the *In View* letter from residents of Northover Court. Chairman has asked Clerk if he will respond. This was agreed.

Ableton Lane - CW, advised by Mrs Davey of Ableton Lane, reported that ‘teens’ are playing ‘organised’ football games on the ground between Ableton Lane and Prospect Road. Contact to be made with South Glos.

ICI, Zeneca & other Industries – NC reported the planned closure of ICI for the regulation clean-up process. This will involve daily visits, from 14th January, by up to 1,000 personnel. The process will last 14 days.

7 – 4 Reports

CEMETERY/CHURCHES (TRINITY HALL) – PT reported the receipt of a ‘thank you’ letter from the Methodist authorities, following their visit to the parish council meeting last month. Clerk confirmed he had not received any communication.

ROADS/ROAD SIGNS – PT informed members that the roads at both Pilning and Redwick & Northwick Schools have been added to the gritting schedule. SC confirmed that gritting has already commenced in Bank Road.

SEVERNSIDE SIREN – PT confirmed the siren noted by FT was the monthly COHMA zone test signal.

ENVIRONMENT/CONSERVATION – PT confirmed that applications are before the Secretary of State for wind power developments at both Ingst and Avonmouth.
