



### 2. Are you renting your property, or do you own it?



















Countryside & outdoor environment, community & people and convenient location & road connections appeared in the top three likes of all areas of the Parish.



Traffic and road issues included volume of traffic on roads (especially HGV's) and the resulting noise and pollution. Through traffic, often speeding (including HGV's) is an issue, particularly identified by Pilning. The industrial development and the not yet opened M49 junction were commented as the major contributors to these issues.

For Severn Beach lack of local amenities scored higher than traffic and roads. Amenities covered a wide range of services from pubs, restaurant, takeaways, chip shop and community centres.

As well as contributing to the road issues, the industrial development is seen as destroying the countryside, encroaching on residential areas and causing noise and light pollution.

Parking as an issue was primarily raised by residents in Severn Beach and New Passage.

Unauthorised development issues were only raised in Pilning and Northwick.





































33. How often do you or the members of your household use the public green spaces in our Parish?





The sea wall and the green spaces behind the sea wall are very popular and used by all areas of the Parish.


Local green spaces in new housing development areas are identified, e.g. Gorse Cover Road and Cranmore Green and should be considered for inclusion in future developments.

## 35. There are sufficient green spaces and recreational areas within the Parish. Do you agree?







Planting more trees was by far the strongest suggestion. As well as the many benefits of having more trees, concerns were raised over the destruction of trees due to industrial development and trees that have died not being replaced.

Many suggestions were made for the creation of areas for wildflowers and how these could be managed.


For both tree & wildflower planting, several proposals for possible sites were made.

Additional litter picking and provision of bins and skips were suggested to address litter issues. More robust actions were requested to deter fly tippers.

Although not suggestions as such, residents asked for many things to be 'stopped' to protect the ecology, e.g. industrial development, removal of trees, filling in of ponds and hedge cutting.







Responses indicate mixed views on aspects of the halls. Although the condition of halls in general is seen as adequate, the top responses to both village halls are that they need improvement.


Opinions on Severn Beach VH and Mafeking are that they are well-maintained and run.


Requirements for pubs/bars were identified by all areas of the Parish. Severn Beach has no pub/bar for residents or the growing numbers of visitors. Pilning too is missing a pub/restaurant as a meeting in the centre of the community.

There's a shortfall in facilities for youths/children. In particular, no youth clubs.

Although the Parish has several halls, none appear to meet expectations of providing a community hub or social club for meeting people.



There is a need for opportunities for social engagement for youths and teenagers in the way of youth clubs, social clubs, community hub, café, etc. facilities where these Issues around locate, can and volunteers/staffing/vandalism would need consideration.


Sporting activities and facilities are needed to give young people things to do locally and give potential for healthier lifestyles. Lack of sports clubs was raised; although outside of the scope of the Neighbourhood Plan, preserving and developing appropriate space and facilities may give them a chance to develop.

For outdoor activities there was a range of different suggestions with 29 for the need for a skate park. BMX, scooters, mountain bikes, roller skating zip wires, etc. were mentioned, but there were only 3 specific requests for a 'pump track'.

For younger children, comments received were significantly less and were largely about play equipment and facilities and playgroups.


The largest response was for pubs. In particular Severn Beach has no pub and a pub/family pub was identified. Pilning too identified the need for a good central pub.

Closely behind this were takeaways, such as a fish and chip shops and other food outlets. Requests for restaurants also appeared widely.

Post Office services were identified particularly for Pilning, but also to be outside of McColl's in Severn Beach. More retail outlets were identified including a Tesco Extra, Co-op type shop 13% of responders made no comment or felt there was sufficient retail & business outlets.





Less than 10% of responses disagree or strongly disagree that the Neighbourhood Plan should continue to support the aim of expanding the green belt south from Severn Beach to the current Western Approach boundary. From some mixed response here and in other questions, there appears to be need for provision of further explanation of what the green belt is.



48. The Neighbourhood Plan should attempt to limit the construction of large commercial developments within the Parish. Do you agree?








49. Do you think that the large commercial developments in the area have benefited the Parish? (Free text answer)



### 50. What age groups make up your household





#### 51. Please tell us about your employment status (paid and voluntary work)





#### **52.Where are you employed?**






