7. AGENDA7 – 1 Sevenside Development

With arrangements for the external audit now made, Clerk raised the topic of the internal audit, conducted from the outset by John Shaw, formerly an officer of Avon County Council. Clerk outlined the procedures followed and members agreed the process to be satisfactory. Whilst the need to review this system, formerly mandatory, has recently been withdrawn, it was felt by the Clerk to be worthy of mention.
