7. AGENDA7 - 1 Sevenside Development

Nothing to report.

7 – 2 Village Halls/Playing Fields

DH reported that swings at SB playing fields had been removed, following vandalism. The committee has not yet decided on whether to replace them.

IH stated that Pilning VH committee is looking into the possibility of installing gas central heating at the hall.

NC drew attention to the pot holes that have reappeared on the drive. DH is to speak with Mr Thompson to see if he can deal with this.

7 – 3 Parish Plan

BM informed the meeting that with the licence now granted the farmers' market will get under way on Wednesday 21st January.

7 – 4 Youth Activities

NB spoke of efforts involving Phoenix Trading and the sale of greetings cards. The sum of £8 has been donated and will be banked against future play equipment.

7 - 5 Travellers

A lengthy discussion covered the efforts so far. DN reported on his visit to the ENC meeting in Thornbury, at which comment was barely encouraged and the presenter was not prepared to depart from his planned presentation and unwilling to be helpful. DN, along with DH, IH and IR, together with the Clerk, had attended the presentation at Easter Compton VH. The information boards told the same story as literature already received by council and officers present were unable to answer any questions relating to the background of the process, merely being able to confirm information on display.

The response to enquiries directed to Patrick Conroy is to be answered by a response drawn up by DN. All present were reminded of the Public Meeting at Pilning School on Monday 8th December, 7.00 pm. IH to invite the press.

7 – 6 Cenotaph

DH applauded the attendance of so many children at this year's Remembrance Service. It was also pleasing that the Police had properly organised the traffic flow in order that no problems were caused for those at the service.

7 – 7 Village Matters

Roads/Road Signs – IR asked whether travel plans for local schools include the provision of crossings, SB School suggesting near the school and at the mini roundabout.

IR asked for renewal of road markings at Little Green Lane and Church Road.

Planning – DN questioned the delays involved in dealing with comprehensive planning applications, suggesting communal appraisals to beat time constraints.

Wainbridge Crescent – IH reported that some residents have expressed their concerns over speeding in this *cul-de-sac*, suggesting the need for some calming measures.

Local Facilities & Amenities – IH queried S Glos Council's lack of commitment to the library at SB PO. Suggested this could be due to funding being directed to the mobile library. S Glos acknowledge the existence of the library but do not provide any financial assistance. Should this continue perhaps the parish council could become involved.

7 - 8 Reports

SIRENS TRUST – PT advised members that the siren would be tested this Wednesday. PT is now chairman of the trust.

SCHOOLS – PT attended the recent open day advertising the St Peters School development. Amazingly only 1 person attended – the owner of the land due to be compulsorily purchased. PT again attended at UWE, being impressed by the high level of creative thinking put into the current project.

SECOND SEVERN CROSSING – PT mentioned an ITV programme on the Second Severn Crossing, due to be shown on Friday 19th December.

DECLARATION of INTERESTS – PT suggested that members should be given the opportunity to declare any interests before consideration of any topics.

CEMETERY/CHURCHES – NC provided copies of the notes on the recent cemetery committee meeting. The committee asked the Smith family to make some minor alterations, but in broad terms the memorial is to remain in its present form. The Clerk questioned this decision, which ignored regulations. In questioning the actions of the family the Cemetery Clerk had followed regulations. The Clerk deplored the decision - a betrayal of the employee - stating he would be recording his protest. Agreed that future disputes be referred to council; not left for the Cemetery Clerk to deal with.
