8 AGENDA ITEMS

.1 To decide on a grant to 1st Severn Beach Scouts for "Bleed kits"

Grant application from 1st Severn Beach Scout Group for spare bleed kits for the parish and for back up at Scout camps.

Proposed £250 ND seconded VB all agreed.

.2 To decide on a grant to Citizens Advice Bureaux

Grant application from Citizens Advice South Gloucestershire. 118 residents of Pilning & Severn Beach were helped by CAB with 620 different referrals.

Proposed £550 VB seconded ISR all agreed.

.3 To decide on the grant of funds to Severnside Events Committee

Grant application from Severnside Events (not for profit umbrella organisation) who are looking to put on a variety of events for the benefit of residents in the parish.

Proposed £3500 VB seconded JO all permitted agreed. Note ND, PT and MP were not permitted to vote as they are committee members.

.4 To decide on a parish approach to parking along the King Charles III footpath

Now the KCIII coastal path has reopened, a bigger footfall is being experienced in the parish. The Neighbourhood plan Steering Group have been considering potential locations for increased car parking provision.

Land next to the Tea Cottage This is a piece of South Glos land and the Parish Council would need to work jointly with the unitary authority to bring this into use as a car park. There could be a large capital expense for which the Parish Council would need to consider a Public Works Loan. This location has the advantage of being close to the centre of Severn Beach.

Shaft Road – Potentially a cost-free piece of land but negotiations will need to be undertaken by South Glos and the landowner.

New Passage Road – there is one plot of land available on a rental basis.

ASEA compound on A403 – owned by South Glos Council

.5. To decide on a response to the SGC "Sort It" consultation.

Councillors expressed a number of opinions and after discussion there was not an overwhelming consensus. Councillors were then encouraged to make their own representations to South Glos and for details to be put into In view for residents to take part as well.

.6 To decide to ask South Glos:-

a) how renewable energy infrastructure will impact the parish

b) how flooding will be mitigated with land raising taking place

c) what measures are in place to raise the quality of water habitats

Resolved for PT to draft letters for each of the subjects in item 6 and share with the Clerk to forward to South Glos

.7 To decide on a programme of tree planting

Several locations have been considered by PT and MP as possible places for trees and hedges to be planted. There is a plan to plant a hedge between Pilning Cemetery and the Parish allotments. Consideration was given by the Parish Council getting a supply of whips for residents to plant themselves. This initiative will be included in "In view" asking for suggestions.

Resolved to get residents feedback on suitable locations.

MP reported a near miss with a juggernaut whist out cycling on Council business. What can be done by South Glos to support safer cycling and walking routes in the parish.

VB has been contacting environment agency and South Gloucestershire Council with enforcement work in progress. Contact has been made with Network Rail regarding the possible installation of a gate at the station. NR replied that the matter is being dealt with by GWR and the Clerk is in the process of finding out who is responsible for it.

.1 Severn Beach Village Hall

.3 Pilning Playing Field

Access is poor at the tennis court end of the field; it requires attention and is currently very muddy and slippery under foot. Note the path is the remaining part of the occupation crossing for the former railway line.

With the wet weather it is difficult to see where tenants have yet to make a start this year. One tenant remains unpaid, Clerk to chase.

.5 Pilning Allotments

As good as can be expected for the time of year.

.6 To receive a report from the Cemetery Clerk

The Cemetery Clerk has been dealing with some quite negative feedback from the conifer tree not being felled. Debris from the tree felling needs to be sorted out as a matter of urgency. Grave owners are being contacted, where required to remove items not permitted in the grave decoration policy. It is particularly unfair on those who are following the regulations to have to put up with graves being inappropriately decorated. Cemetery Clerk has refused a permit until unregulated items are removed from the grave in question. The grave decoration policy is being actively enforced; Councillors were notified that there may be an increase in contact from grave owners unhappy with the grave decoration policy. A caretaker, to look after graves, leaves and paths (particularly during the winter) is a good idea and is supported by the Cemetery Clerk. Work agreed in the old cemetery section should be done by the end of May.

Question raised by the Cemetery Clerk as to the best way to communicate action needed at the cemeteries.

Request for a noticeboard in the new section of Pilning Cemetery.

Resolved to get quotes for a double noticeboard and to add to the next agenda.

Report from OT had been circulated.

The trains in February ran (more or less) on time, there were no cancellations; there were no obstacles for passengers to start and end their journeys at Pilning. All stopping units were the latest electric trains (Hitachi Class 800, IETs). The crew were aware of the Pilning stop and on some occasions made additional announcements alerting passengers of the limited services at Pilning station.

The approach and the car park have been cleared out.

VB has obtained ownership plans from Network Rail under a Freedom of Information request, confirming where the land ownership boundaries are.

Appendix C NPSG Report

Neighbourhood Plan Steering Group (NPSG) Report to Parish Council 4th March 2024 – delivered by Richard Edwards. The NPSG meeting since last PC meeting was on 20th February. Matters discussed and arising since are as follows:

Guests: We were pleased to see ten guests including one Parish Councillor attending the meeting. We believe the increased interest was largely due to the consultation on the Local Plan and the discussion around that at the last PC meeting. The NP meeting would have been relatively short, but we took time to explain to guests, the background to the meeting's topics, the relationship with the Local Plan and to answer questions.

Local Plan: The Steering Group has formally submitted its comments on the draft Local Plan through the SGC consultation website. Additionally, we've contacted Chris Wilmore, Jack Lopresti and Matthew Riddle to identify to them where we consider the LP could undermine the efforts of the NP.

Flooding: Since our meeting with the Environment Agency at the end of January, the Steering Group has been awaiting the re-modelled 100 year flood risk data. Until we get this the NP is essentially on hold. We were told by the EA the data was due to be available at the end of February. But this is yet to materialise. Additionally, our request for an update for this evening has not yielded a reply.

Evaluation of Sites:

- We've had a response from a landowner at New Passage who is prepared to make land available for car parking but would prefer to do this on a rental basis. It was agreed this opportunity/information should be put to the PC to take up with SGC.
- An email response has been received from Chris Cox, SGC Property Services, to the Group's request for information.
 - For the use of land at SB School, SGC needs to understand the required scope, by the provision of a plan of likely land take. The Group has put the developer in contact with SGC.
 - Release of SGC land at Promenade Gardens, SGC has indicated this can be considered, but a plan of the proposals in the first instance is required. This has been communicated with the PC to prepare a response.
 - Copies of plans were provided for the original Cross Hands Road entrance to the new St Peter's School. These have been sent to the PC for their consideration as a new access to the playing field.
- There are now three options to be identified in the NP, available to provide carparking for visitors to Severn Beach and the coastal path; Promenade Gardens, Shaft Road and New Passage. The Steering Group is not a developer, so how these can be delivered will need to be determined by the PC and SGC. Considerations will need to include; leasing or purchase of land, methods for construction and infrastructure needed, running costs/payment for parking.

Pilning & Severn Beach Parish Council Report | Monday 4th March 2024

Key updates for Parish Council colleagues in March 2024;

- Local Plan consultation has now closed and the feedback from across the Local Authority being reviewed, assessed and collated to develop a final preferred strategy for Council consideration. Thank you to everyone locally who has promoted the consultation and encouraged feedback. I'm always available on email to answer local questions and discuss any proposal.
- The MAF year has concluded and I'm pleased to have used the fund locally to support the Severn Beach Library, the FACE and KRUNCH Youth Consultation and to support St Peter's Hospice, who supported residents in Bristol and South Gloucestershire.
- Claire Young, Leader of South Gloucestershire Council has written to the Secretary of State for Transport in relation to protecting the Severn Beach railway. Additional funding is being sought to extend the flood defences to alleviate any disruption caused by closures linked to climate change and flooding.
- At the February Council meeting, the Council debated the Council budget which was a difficult and challenging process to manage. We have been able to balance the budget in the next few years by using reserves, but still have challenges ahead with reduced UK Gov spending. The costs of delivering our vital services and work in increasing and we've worked hard to protect these vital services wherever we can.
- We're awaiting an update meeting following the conclusion of the Youth Consultation with local people in the ward. We'll aim to present this information and findings back to the Parish Council in an upcoming meeting.
- I have liaised with Officers relating to the M49 Junction and been advised that a local update will be available very soon (imminent) on the South Glos dedicated webpage. The aim remains to be on site as soon as possible, ideally this summer.
- The Lower Severn Drainage Board are recruiting for new eligible Board members, information on the criteria and how to apply has been shared with the Parish Council.
- WECA are consulting on an expansion to the E-bike and scooter trial across the combined authority. This information will be shared with the Parish and feedback sent to WECA to ensure we maximise the opportunity for sustainable travel in the ward and local area.
