<u>Green Belt extension</u> after a decision at the October meeting it was decided to ask South Gloucestershire Council to move the Green Belt boundary further south to border the ASEA (Avonmouth Severnside Enterprise Area). The Clerk circulated the reply from Patrick Conroy at South Gloucestershire Council, this suggests that the Parish Council gets a consultant in to argue the case for us. Concern was raised that the Creswell Report was being misinterpreted and that the lakes in Orchard Pools are part of the mitigation for the development on Severnside. **Proposal to seek guotes from consultants for this work, agreed unanimously**

<u>Notice of Vacancy</u> The statutory period has now been completed. Clerk to get confirmation from South Gloucestershire Council that the post can now be co-opted.

<u>Basketball lines</u> the Clerk has obtained a quote for lines on the basketball court. Soft surfaces Ltd $\pm 1500 + VAT$. South Gloucestershire Council were also asked if they could undertake the work but no reply from them. Doubts expressed over whether a "DIY" approach would not be hard wearing enough. Suggestions were made to the Clerk for other contractors to be contacted.

The Parish Council agreed that it is not an issue with which they can progress. <u>Flood systems update and flood risk</u> a volunteer was sought to look at the information circulated by the Clerk previously.

<u>Platinum Jubilee Beacon</u> the Scouts are willing to help with the beacon and provide catering for the event. Neither they nor the council are interested in purchasing a special gas fired beacon for the occasion. Any beacon will be undertaken using driftwood and untreated pallets. Suggestion was made that the beacon could be lit on the foreshore but that will be dependent on tide times. Consideration is to be given to where power will come from and whether there will be entertainment as well.

<u>Remembrance Sunday</u> the meeting was given an update on preparations for the commemoration. The Clerk confirmed that poppy wreaths on behalf of the Parish Council had been obtained. As well as the Pilning act of remembrance there will be a further act at Northwick Churchyard at noon on the same day.

8 AGENDA ITEMS

.1 To decide on asking South Glos to compulsory purchase land at Severn Beach station

Consideration is being given to getting another developer interested in the site next to Severn Beach railway station. PT and ISR are to find out who South Gloucestershire Council's social housing developer is. There was concern from one Councillor that the site should left as a nature reserve.

Resolved for PT and ISR to investigate further

.2 To decide on adopting a Strategic Transport Strategy for the Parish

Two documents are under consideration one written by PT and the other by SevernNet. Councillors are asked to read and comment on them both. An invitation was suggested for a SevernNet member to speak at a Parish Council meeting in the New Year. Item to be mentioned in In View.

.3 To decide on flooring for the teen hut at Pilning Playing Field

Discussion paper circulated previously by the Clerk regarding options for the flooring. **Resolved to remove the remaining flooring completely and leave the area inside the Teen hut to grass / mud.**

.4 To decide on adopting Pilning station

PT had asked SevernNet about their experiences adopting St Andrews Road station but is awaiting a response. Concern was raised that this could cause the Parish Council additional liability and expenditure. OT to write a proposal for Councillors to consider.

.5 To decide on joining the Town and Country Planning Association

After discussion it was agreed to join the Association for a year and review it again in November 2022 and authorisation for the Clerk to pay for the membership. **Proposed - all in favour**

.6 To decide on a grant application by Severn Beach Village Hall

Details of the grant application circulated to Councillors previously. After discussion it was agreed to fund the four windows but the door needs further consideration. The door plans need to be

looked at further by Severn Beach Village Hall Committee to ensure better compliance with disability access. Suggestion was made that the door frame is fixed on the outside of the building making the aperture wider without the need for structural building work.

Proposed and seconded agreed unanimously to fund the replacement of four windows Action JE

.7 To decide on paying fees for Pilning Village Hall Monitored Alarm

Correspondence circulated previously to Councillors regarding this request from Pilning Village Hall Management Committee.

Resolved for the Clerk to check the insurance details regarding the monitored alarm.

HR and SCB will be looking at claiming money from South Gloucestershire Council for the Platinum Jubilee Grant. The application needs to be in by 12th November 2021. SCB gave a report of events that might be eligible. A plan is needed for an event, the beacon event could be eligible. A quote was presented for commemorative mugs for the Platinum Jubilee for consideration, for 500 mugs the cost would be £1215.00.

9 The Neighbourhood Plan

Neighbourhood Plan Steering Group Chair gave an update to the meeting

- The election of Richard Edwards as the new Chair of the Steering Group and Anuran Wickramasinghe as Vice Chair.
- Either Richard, Gary Sheppard or Anuran will be coming to future meetings to give an update on the progress of the Neighbourhood Plan.
- Housing Needs Assessment has been sent back to the author following comments from the group regarding the need for specialist housing e.g., care and sheltered accommodation in the report. The revised report is expected soon.
- Survey of residents will be sent out later in November.
- Councillors were encouraged to sign up for the electronic version of the survey and to get friends and relatives to sign up as well.
- A request was made to Councillors to assist with delivering the surveys to households.
- Request for the Parish Council article in In View to include information about the survey and the importance of returning the surveys by 22nd December.
- Clarification was given as to the role of Neighbourhood Plan Steering Group in relation to the Parish Council. The relationship is important but the group has been given devolved responsibility to deliver the plan and as such will keep the Parish Council informed. However due to the evidenced based nature of the Neighbourhood Plan the group will not be seeking the approval of the Parish Council at each stage. PT Noted that it is for the residents to decide on the Neighbourhood Plan through the referendum at the end of the process and not the Parish Council.

• It is important that the Parish Council keeps the Neighbourhood Plan Group informed of what is happening in the Parish and where any relevant documentation is shared with them.

The Neighbourhood Plan Chair was thanked for his summary of the work being undertaken.

11 Updates

11.1 Village Halls

11.1.1 Severn Beach Village Hall

MP had not attended the last meeting of the Village Hall Committee.

<u>Severn Beach Graffiti</u> - Concern was expressed that the continued presence of graffiti of the building and front wall is letting the village down and that the Village Hall Committee should get it painted over as soon as possible.

<u>Accessible toilet at Severn Beach Village Hall</u> - At the recent Local History Group event in the hall a visitor had to go home early as there was not a suitable accessible toilet to use. Could the management committee look at this issue?</u>

11.1.2 Pilning Village Hall

No meeting recently as the Village Hall Committee were not quorate. Regular users of the hall should be encouraged to take part in the running of the building. Volunteers are needed from the village to form a committee. Article to be put into In View to encourage engagement.

Resolved to add an agenda item for the December meeting regarding the future of the hall.

New play equipment ordered for Pilning Playing Field, expected to be installed in January 2022. One basketball hoop is missing and the other broken, Tim Dark has the new hoops in hand to fit.

11.2.1 Severn Beach Allotments

There are five plots not being worked satisfactorily Numbers 4, 8, 22, 25, 29. Tenant for plot 8 never got going and has given it up and 22 has given up due to ill health. All the rest are being worked well with plenty of winter veg still being grown including lots of varieties of pumpkins and squashes.

Flooding is an issue as usual at this time of year with some plots well under water.

There are still reports of the public exercising their dogs around the allotments and not cleaning up after them. Perhaps something for In View?

Resolved to ask South Gloucestershire Council drainage engineer to look at the site and advise on any remedial work to the rhines.

Dear Ward Members,

M32 Junction – The current status is that South Glos. Council have agreed a joint negotiating position with Officers. Highways England and WECA who have the £1 million I requested to join with the landowners and South Glos. Council to decide a path forward. Initially the landowners agreed with Highways England they were going to pay for the link road but they have changed their stance.

Bank Road, Pilning – incident 130921 JT. A reply has been received from South Glos. Highways.

<u>Community Engagement Meeting</u> – Our Police Beat Manager in his report stated that Beach Road, Severn Beach was visited regularly to ensure the parking was acceptable.

<u>Masks</u> – I saw an official sign to-day in Southmead Hospital suggesting fabric masks should not be worn. Only disposable versions are recommended whist visiting hospital.

Vaccinations – The over 50s are being offered both flu and covid vaccines boosters to try to reduce the incidents of respiratory illness during the coming winter and protect our hospitals. This task seems to be in full swing with local surgeries playing their part. Young children under 5 have a nasal spray under test. The over 5s can already use it.

<u>GWR Annual Stakeholders Conference</u> - took place in Cardiff. I was offered a free rail ticket but declined for personal reasons. The only positive item mentioned was the new station in the Avonmouth Park and Ride site. GWR are running the Covid subsidised 50% timetable until late November. No mention yet about the next timetable or the extended services from Severn Beach to Bath and Yate. The additional trackwork has been completed by Network Rail for the Hallen Loop and the additional two extra lines to Temple Meads via Abbeywood. Many aspirations were expressed but un-costed.

<u>BT/Openreach Broadband</u> – On November 4th, telephone access will be upgraded to Digital Voice by plugging your phone cable into your Smart Hub/Router after removing a sticker from this box. Help can be obtained from bt.com/digitalvoicemigraion.

<u>Meat Consumption</u> – Over the last decade eating this type of food has reduced by 17%.

HNO – Owners of houses without Planning Permission for multiple occupation have been fined £7,000 in the last year.

<u>Malaria Vaccination</u> – This is taking place in the infectious areas of sub-Saharan Africa. A child will need four doses during their lifetime. This virus breeds in the elevated lakes of this continent. From my memory it's above 6,000 feet. It is hoped to save 14,000 children lives per year of this aggressive disease.

Sickle-cell anaemia – In this country a gene treatment is being released to stop these sufferers being hospitalised regularly. In the light of this the blood donor list has been refined.

New chemotherapy drug – This compound has been refined from a Himalayan fungus and is more powerful than current anti-cancer drugs. It has been used for centuries in Chinese medicine.

Cop26 – as a pre stance you might want to carry out a personal household audit.
