8 AGENDA ITEMS

.1 To decide on continuing additional copies of In View

In anticipation of the increased numbers coming to the parish for the Centenary and Jubilee additional copies were ordered from Compton Publishing.

There is some conflicting information about how these additional magazine has been distributed.

.2 To decide on a picnic table and benches for Gorse Cover Road

A resident of Gorse Cover Road spoke for the proposal and after discussion the proposal has been amended to consider two benches for Gorse Cover Road instead. The cost of the revised scheme will be in the region of £1200.

Concern was expressed that South Gloucestershire Council's indemnity clauses are too restrictive. It has been noted by the Neighbourhood Plan Steering Group survey that there is a lack of suitable benches through the parish.

The Parish Council has received information from South Gloucestershire Council and National
Association of Local Councils regarding Electric Vehicle Charging. PT was asking if the Parish
Council could consider providing EV charging at Village Halls.

.4 To decide on a letter to SGC and Highways England regarding their traffic strategy

The recent issue of a fire on the Prince of Wales bridge (and to a lesser degree a large concert in Cardiff) brought into sharp focus just how vulnerable the road network in the parish is.

Resolved for a letter to be sent to South Gloucestershire Council and Highways England to ask what their traffic strategy is.

.5 To decide on a letter to SGC re Active Travel options through the parish
Part of the information sent for Electric Vehicle Charging contains details of "Active travel" e.g.,
walking and cycling. Concern has been expressed that the condition of the pavements in the
parish is so poor that walking has been made near impossible in places. Also, that cycle lanes are
intermittent, not being maintained and do not provide a good transport option.

Resolved to ask the District Councillor to ask South Gloucestershire Council Highways for comment and report back.

.6 To decide on a request to SGC to reduce the speed limit on the rest of Redwick Road to 20mph.

Concern from a resident on the western part of Redwick Road that speeding has been and still is a major problem.

- Twenty years ago, a petition was organised to get the speed limit changed
- Traffic coming from the A403 is mistaken in thinking that this part of Redwick Road is 50 mph when it is 30mph. Note that the 30mph limit sign is obstructed by another sign.
- BAM Nuttal vehicles are speeding along the road.
- There is only a footpath on the north side of the road and therefore crossing the road is extremely hazardous.

Vote unanimously

• for the Clerk to write to SGC to ask for a 20-mph limit from the A403 through to junction with New Passage Road.

PT asked if the land by plot 4 owned by South Gloucestershire Council could also be rewilded. Resolved for the Clerk to ask what the programme is.

Paper circulated previously setting out the aims and objective in getting a mobile phone for the Parish Council and to cease using an unnecessary broadband package.

Councillors want to see the land line retained as it is a well-known number. Consideration should be given for the Clerk to buy a phone for the Parish Council outright rather than use a contract.

Proposed and seconded eight in favour and two abstained. Motion carried.

11.1.1 Severn Beach Village Hall

The most recent committee meeting minutes had been circulated.

11.1.2 Pilning Village Hall

New cess tank has been installed and the hall reopened on 1st September, the Village Hall Management Committee are thanked for getting this very long-standing issue resolved. Now this issue has been resolved the committee are looking at getting other pressing maters dealt with and fundraising will be key to that taking place. Agreement was reached to pay for this work at the July meeting

11.1.4 Pilning Playing Field

Pilning Playing Field has been cut and is tidy.

There is damage to the Kompan Super Nova.

New graffiti has appeared on the teen shelter.

With the agreement of PT and SCB, Relyon have been employed to make visits to Pilning Playing Field during July, August and September. Cost to the Council of £117.00. As there have (so far) been no reports of any serious vandalism at the Playing Field this summer this appears to have been beneficial.

11.2.1 Severn Beach Allotments

Some of the plots have let the paths between the plots become overgrown and difficult to pass. A general email needs to be sent reminding the plot holders of their responsibilities to keep the paths clear.

Three plots that were being worked on have tailed off in the last months namely 22, 25 & 29.

11.2.2 Pilning Allotments

Looking tidy, all plots are let.

11.3.1 Pilning Cemetery

Just been cut and is looking tidy, despite the excellent efforts to weed the gravestones in May there is a need to revisit graves again.

There is an extraordinary meeting of the Parish Council on Tuesday 18th October 7pm at St Peter's Church to discuss cemetery matters.

The dry period has caused issues of cracking around the cemetery. SCB considered whether getting signs made to warn of the uneven ground would be a good idea.

11.3.3 Northwick Tower update

Working group met at the tower on 31/08/2022, notes from the meeting circulate to Councillors previously.

Funding for the tower repairs will be spread over two financial years but given the amended method of undertaking the work it should be more straightforward to get quotes and therefore grants. Not scaffolding the tower from the outside will significantly reduce the cost to the Parish.

11.4.1 Pilning Station

Passenger services have been affected by recent rail industry strikes, so passenger numbers have been disappointing. OT expressed concern at the continuing sorry state of the station approach.

11.4.2 Severn Beach Station

Generally, engines have been turned off on arrival.

Noted that there have been repairs carried out to the waiting shelter.

The Rail partnership are sending a team of volunteers to paint the fence at Severn Beach station. The Parish Council appreciates that this is being done.

15 Planning

.1 Ongoing planning applications

PT reported concern over <u>P21/07616/F</u> and that the Parish Council's submission to the planning committee has been completely ignored and that the mess of temporary buildings etc. under the Prince of Wales bridge is being allowed to continue. RG has been told that senior officers have been asked to liaise with the Parish Council regarding the conditions on the planning consent. "So called" Plot 9000, this has previously gone to committee, site visit and South Glos then refused the application. A second South Glos planning committee also with their own site visit then refused the application again. Applicants have now lodged an appeal.

Resolved for the Clerk to send the appeal case officer the responses given by PT to the various committees and site meetings to make sure they have the Parish Council's side.

News for Pilning, Severn Beach, Easter Compton & Hallen. September 2022

Dear Ward Members,

We are in a session of drought. – Supermarkets have withdrawn disposable barbeques from shelves. Rivers and reservoirs are running low. Many areas have hosepipe restrictions. 60 public swimming pools have closed in the last three years. Government advice is for individuals to reduce their water consumption. About ten years ago there was a scheme proposed by academics and engineers to move water south utilizing rivers and canals that already exist. It had the advantage of reducing flooding in the northern counties during winter. It was a national water grid. It seems to have been put on back burner but first the dumping of sewage in rivers must cease.

South Glos. Planning – I have had emails and phone calls about delays in the planning process, also, the development at the Bank Road and the Northwick Road junction. The state of the land behind the Cross Hands is also mentioned. These are in the hands of Planning Enforcement, but I will continue to monitor them as they are matters of great concern locally.

McColl's – shop at Severn Beach is still operating an intermittent Post Office counter service to the annoyance of some residents but there are staffing problems.

P21/07616/F – Shaft Road. I was requested to attend the Planning meeting of the Development Management Committee as I had called it In. I would like to thank Brian Hopkinson for all his research work on past permissions etc. The Parish Council will be contacted by Planning for consultations in due course.

School Uniforms – from September government legislation has changed and schools can no longer specify a preferred provider. It is encouraging that second hand uniforms are still being passed on. Hospital waiting lists – 22,000 patients waiting over two years have now been operated on. Well done. However, many outstanding procedures need to be carried out. 7,000 extra beds have been commissioned for the winter.

Haemophilia status - the 4,000 patients have been receiving £100,000 temporary compensation and more could follow.

Polio vaccination – children in London between birth and nine are being offered a booster after more than 100 specimens of the virus have been found in wastewater.

Student Grants – their loan interest rate will be capped at 6.3%.

Bristol Zoo, Clifton - This excellent asset of the city has closed down and the animals are being re-housed in suitable accommodation including the Wild Place. Do visit the Wild Place as it a great day out and local.

APPENDIX D - PRESENTATION FROM SGC REGARDING M49 JUNCTION 1

The Parish Council were pleased to hear a progress report from Kelvin Packer (KP), South Gloucestershire Council project manager.

<u>Planning</u>

South Gloucestershire Council has taken legal advice and concluded that to make progress as smooth as possible pre planning advice and a full planning application will be required. This will be submitted for consultation before the new year. This will not affect the timescale of the project Surveys are currently under way for

- Transport
- Ecology
- Drainage & flooding
- Landscaping
- Screening options

Design

Consideration is being given to whether the construction will be a solid earth embankment which is given time to settle or a concrete pile embankment. This is dependent on the available land and the results of a Geotech survey. Also there are longer term maintenance issues with a concrete pile embankment.

Land acquisition

South Gloucestershire Council are dealing with four separate landowners and it appears likely a Compulsory Purchase Order (CPO) will be required for some of the land. If a CPO is required then the timescale will slip significantly by at least eighteen months. Completion around Summertime 2024 would in practice become Summer 2026.

KP was pleased to answer questions regarding the project

OT Transport Planning

Will Pilning station be considered in as part of any transport strategy?

KP - to take this away

ISR Information held by National Highways

Traffic flow information held by National Highways is at least four years out of date, will this be of any use?

KP - the information will be used as a base but updated.

ISR What is a "traditional build"?

KP - Traditional is a solid earth embankment (which is given time to settle) rather than supporting the road on concrete piles. A traditional build would allow grass cutting on the embankment with mowers.

ISR Why not pile driven?

KP – Pile driving was possibly selected as different construction methods may pose a risk of differential settlement. E.g., where a concrete bridge meets an earth embankment

ISR What is happening with the adoption of link roads and estate roads?

KP - South Gloucestershire Council will continue to push the Developer to bring the roads up to an adoptable standard and transfer them to South Gloucestershire Council ND Will Farm Lane remain open? ${\sf KP-There}$ will be access throughout the works and the proper path will be installed instead of the temporary one now.

RE (NSPG) Why is there no declared project plan in the public domain?

KP – confirmation that more information needs to be added to be published, including Facebook and Twitter. There will be a public exhibition this year to give greater detail.
