RESIDENTIAL CARAVANS.

Permission was given by the Planning Officer for the erection of

the Chalet on the land of Mr. Hathway - Redwick Road.

The Officer is taking up the matter with the R.D.C. concerning caravans at Myrtle Cottage and Dean House Farm.

LIFE BELT, SEVERN BEACH. The Councillors were informed it was not practical or economic for the R.D.C. to daily inspect for damage. It was resolved to ask if it is possible to have a routine inspection early in each week following following weekend visitors, and to inquire if a notice could be placed on or near the equipment stating that prosecution will follow if anyone is found damaging the apparatus. It is being presumed there is a bye-law to cover such an eventuality. Anyone seeing persons interfering with the life belt should immediately advise the Police.

SHUFFLEBOTTOM'S IRON BUILDING, BEACH ROAD.

The Planning Officer is not entirely confident he can order this area to be cleared inasmuch it cannot be termed "A vacant Site", but he is writing Mr. Shufflebottom. Apparently this was done, as Mr. Ball states some work has been done at the spot.

- 747. DEAD FISH IN CHESSEL PILL.

 The Parish Councillors expressed satisfaction with the letter received from the I.C.I. who are endeavouring to find the exact cause of the death of the fish. They have taken extra precautions to prevent any ldakage of water used to fight a fire on their premises into local rhines.
- A letter from the Chief Fire Officer at Cheltenham explaining why for for efficiency reasons Firemen were supplied with pocket wireless alerter equipment, and the siren was not now used. The local Fire Officer has instructed his men that the fire engine sirens are to be switched on immediately the machines leave the station, and also Firemen when called out after normal working hours have to sound their car horns on way to the station. Councillors felt this was satisfactory. Matter to be filed.

 Messrs. Wimpeys have recently put in additional drainage and levelled the large play area. When the work is satisfactorily completed the R.D.C. will take over and maintain the area.
- 763. CHESSIL PILL RHINE.

 From a complaint received the Drainage Officer is to be asked to clean out the Rhine near the Pilning Playing Field.
- 764. FOOTPATH, NEW PASSAGE HALT BRIDGE.

 Footpath overgrown. British Rail is to be requested to clear.
- Mr. Frost in detail answered in a letter the reasons why delays had or were occurring. Some had been dealt with since his letter dated 21st July was sent out, the remainder are being dealt with under other correspondence such as Pilning Tip and Flood Alleviation, Warning Notices at Sewage Plant Site etc.
- Cars Parking in Beach ROAD.

 Councillor T. Salmon put in a complaint regarding the parking of cars which takes place on both sides of the road. He considered there would be grave delays in a case of fire, or if an ambulance was urgently required. It was considered some of the trouble was caused by car owners not getting their cars of the road although they had garages. Several suggestions were put forward for improving the position, but all failed for one or more reasons. It was decided to ask the Police to look into the problem.
